The petition of John E. Rottkamp, Commissioner of Buildings of the Town Of Hempstead shows:

- 1. That pursuant to Local Law 92-1981, adopted October 27, 1981, effective date November 2, 1981, which repealed and reenacted Chapter 90 of the code of the Town of Hempstead entitled, "Dangerous Buildings and structures," petitioner submits the following:
- 2. The structure or structures located on premises designated as Section 32, Block 485 and lot number (s) 19, on the Land and Tax Map of the county of Nassau, are in a condition unsafe and dangerous to public safety.
- All parties of interest have been apprised of the condition of the said structure and have been requested to correct the same. Chapter 90 Pre-Notice of Violation letter was sent on March 14, 2012 with a 15-day correction date. The Chapter 90 Notice of Violation letter was sent on July 26, 2012 in accordance with Chapter 90-5 of the code without response. More than 30 days have elapsed since the aforementioned notice was given.
- 4. The parties in interest were advised that a hearing before this Town Board would take place on September 4, 2012.
- 5. As no effort to correct the existing unsafe and dangerous condition has been made, it is requested that this Town Board render a decision that the premises is unsafe and dangerous, a fire hazard and a public nuisance, and that the Commissioner of Buildings forthwith DEMOLISH AND REMOVE THE ONE AND ONE-HALF STORY WOOD FRAME ONE FAMILY DWELLING WITH DETACHED GARAGE, AND REMOVE ALL LITTER AND DEBRIS FROM PREMISES: AFOREMENTIONED PROPERTY LOCATED ON THE EAST SIDE OF STEWART STREET, 52 FEET SOUTH OF STEELE STREET, ELMONT, NY 11003, SECTION 32, BLOCK 485 AND LOTS 19, A/K/A 55 STEWART STREET, ELMONT, TOWN OF HEMPSTEAD IN ACCORDANCE WITH SURVEY RECOMMENDATIONS ATTACHED HERETO AND THAT THE TOWN BE REIMBURSED PURSUANT TO SECTION 90-13 OF THE CODE OF THE TOWN OF HEMPSTEAD.

§ 106-4. Standards.

C. A clothing bin that is subject to the provisions of this chapter must have clearly identified, in writing, on its face the entity or organization that is maintaining the clothing bin. A phone number and address for such entity must also be written on the clothing bin. Additionally, A clothing bin that is subject to the provisions of this chapter is hereby required to have conspicuously placed upon it a sticker provided by the Department of Buildings, indicating that the clothing bin has been permitted by the Town of Hempstead for use in connection with charitable purposes. A]] clothing bins that are lawfully in existence on the effective date of this requirement shall have such sticker placed upon it no later than October 1, 2012. No such sticker shall be removed or covered, except upon permission of the owner of the clothing bin to which it is affixed. No clothing bin with a sticker affixed to it as provided herein shall be relocated or removed from any private property except upon 30 days prior written notice sent by the private property owner to the owner of the clothing bin and to the Town Clerk, by certified mail, return receipt requested, advising of such intent to relocate or remove the clothing bin from the property.

Section Two. This local law shall become effective immediately upon filing with the Secretary of State.
