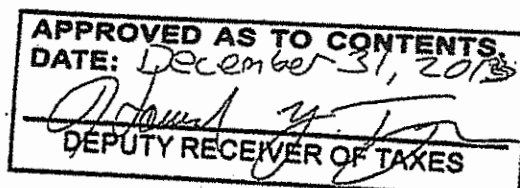
Taxes are payable by cash, certified check and money order. Uncertified checks will be accepted subject to collection only. Third party checks will not be accepted.

It is the intent of this local law, under the authority of special legislation enacted as Section 1662-E of the New York State Vehicle and Traffic Law, to create a residential parking permit system applicable to designated residential streets near Nassau University Medical Center, in East Meadow. The Town Board finds that chronic monopolization of on-street parking spaces in certain residential areas adjacent to Nassau University Medical Center by its employees and visitors has caused a distinct lack of on-street parking for residents of that area, adjacent to their homes. In addition to the great hardship and frustration it has caused among the residents, this adverse condition has also resulted in traffic hazards, congestion, and air and noise pollution. This limited resident-only permitting system for on-street parking in the affected area will fairly address the residents' concerns and also protect the needs of the greater vicinity.

§ 202-66. Regulated Area. The areas of East Meadow that shall be subject to resident-only on-street parking regulation as provided under this Article shall be as follows:

- (A) ROOSEVELT AVENUE WEST OF PROSPECT AVENUE;
- (B) JEFFERSON STREET WEST OF PROSPECT AVENUE;
- (C) FIRST STREET WEST OF PROSPECT AVENUE;
- (D) SECOND STREET WEST OF PROSPECT AVENUE;
- (E) THIRD STREET WEST OF PROSPECT AVENUE;
- (F) FOURTH STREET WEST OF PROSPECT AVENUE;
- (G) CLEARMEADOW DRIVE;

- (H) NOTTINGHAM ROAD;
- (I) FLORENCE COURT;
- (J) JANE COURT;
- (K) DOFENA LANE;
- (L) FRANKLIN AVENUE NORTH OF 4TH STREET;
- (M) BAILEY AVENUE;
- (N) FRANKLIN AVENUE, NORTH OF 7TH STREET AND SOUTH OF HEMPSTEAD TURNPIKE;
- (O) LINCOLN AVENUE, NORTH OF 7TH STREET AND SOUTH OF ROOSEVELT AVENUE;
- (P) 5TH STREET, WEST OF PROSPECT AVENUE;
- (Q) 6TH STREET, WEST OF PROSPECT AVENUE;
- (R) 7TH STREET, WEST OF PROSPECT AVENUE;
- (S) PENGON CIRCLE;
- (T) LOIS COURT;
- (U) ERMA DRIVE;
- (V) AVA DRIVE;
- (W) DOROTHY DRIVE;
- (X) BARBARA DRIVE;
- (Y) ROSE DRIVE;
- (Z) BLY ROAD;
- (AA) MARION DRIVE; AND
- (BB) CONTI SQUARE BOULEVARD.

§ 202-67. Motor vehicles registered pursuant to Vehicle and Traffic Law section 404-a shall be exempt from any permit requirement under this Article.

§ 202-68. Permit Requirement. On-street parking within the Regulated Area set forth in section 202-66 hereof shall be reserved for resident parking only, subject to the following requirements:

- a. A "resident" who is eligible to receive a permit under this Article shall be defined as any person who resides in a dwelling adjacent to any of the streets in the "Restricted Parking Zone."
- b. A "Restricted Parking Zone" shall be defined as designated streets, or designated portions thereof where vehicular parking is regulated by the posting of signs setting the hours of day and days of the week where the display of a town issued parking permit or visitor pass is required.
- c. Such a resident shall be eligible for a permit to park his or her vehicle(s) within the "Restricted Parking Zone", which permit shall be issued by the Town Clerk upon due proof of qualification, as determined by the Town Clerk. The permit(s) shall be of a physical type and appearance, contain such information, and be displayed on the vehicle, all as determined by the Town Clerk. Additionally, and subject to the same requirements, each such resident shall be entitled to four "visitor pass" permits. A "visitor" shall be defined as someone who (a) is a guest of a permit holder (b) shall not pay any consideration to the permit holder in exchange for use of a "visitor pass," and (c) is parking a vehicle in the "Restricted

Parking Zone" for a reason other than proceeding from the vehicle to Nassau University Medical Center. In any event, no more than four "visitor pass" permits shall be issued per household. The Town may issue temporary passes on an as-requested basis.

d. The restrictions for permitted parking as per this section shall apply to the following:

1. "No Parking from 7 a.m. to 10 p.m. Monday through Saturday exclusive of Federal Holidays except with permit." This restriction shall apply to the following areas;

Roosevelt Avenue, between Fourth Street and 2255 Roosevelt Avenue

First Street, between Hempstead Turnpike and Franklin Avenue

Second Street, between Hempstead Turnpike and Franklin Avenue (Excluding 2230 Second Street)

Third Street, between Hempstead Turnpike and Lincoln Avenue

Franklin Avenue, between Hempstead Turnpike and Second Street

Nottingham Road

Florence Court

Jane Court

2. "No Parking from 7 a.m. to 7 p.m. Monday through Friday exclusive of Federal Holidays except with permit." This restriction shall apply to the following areas:

First Street, between Franklin Avenue and 2283 First Street

Second Street, between Franklin Avenue and 2294 Second Street

Erma Drive

3. Notwithstanding the foregoing, the designated times of day and days of the week may be adjusted by resolution of the Town Board, as recommended by the Director of Traffic Control.

- e. Notwithstanding any provision of this Article to the contrary, not less than 15 percent of the Regulated Area shall be available for lawful parking by nonresidents and non-permit holders. The Commissioner of Engineering shall prepare a map demarcating the said 15 percent area, and it shall exclude areas in which on-street parking is illegal at all times for passenger vehicles. This area shall be comprised of the 15 percent of the total Regulated Area which shall be adjacent to properties which are zoned and used for non-residential use, plus, as necessary, the portion of the Regulated Area adjacent to residential use which is farthest away from the main entrance to the Nassau University Medical Center. Such map shall be filed in the Town Clerk's office. Notwithstanding the foregoing, the demarcation of the designated 15 percent area may be adjusted by resolution of the Town Board, as recommended by the Director of Traffic Control, whereupon a new and updated map shall be prepared by the Town Engineer and filed in the Town Clerk's office.
- f. Notwithstanding any provision of this Article to the contrary, no permit shall be required on those streets within the Regulated Area where the adjacent properties are zoned and used for non-residential use.
- g. These regulations shall be in addition to all existing on-street parking regulations in the Regulated Area.
- h. Notwithstanding any provision of this Article to the contrary, parking of commercial vehicles while performing a service to residents shall be permitted without a permit.

§ 202-69. Signage. The Town Board may by resolution or local law authorize placement of such signage in the Regulated Area as it deems reasonably necessary to notify the public that the Regulated Area is limited to resident-only permit parking, as provided herein.

§ 202-70. Prohibition. Any person who parks a motor vehicle in a restricted area without a parking permit for such area shall be guilty of a violation.

§ 202-71. Penalties for Offenses. Every person committing an offense against section 202-70 of this Article shall be guilty of a traffic infraction and shall be punished by a fine of not more than \$125; for a conviction of a second violation, both of which were committed within a period of 18 months, such person shall be punished by a fine of not more than \$250; upon a conviction of a third or subsequent violation, all of which were committed within a period of eighteen months, such a person shall be punished by a fine of not more than \$375. The owner and lessee of a vehicle illegally parked hereunder shall be considered a "person committing an offense against this Article." All tickets issued by the Nassau County Police Department or any other duly qualified officer for violation of section 202-70 of this Article shall be returnable at the Nassau

County Traffic and Parking Violations Agency. All remedies which are available to police in the case of tickets returnable at the Nassau County Traffic and Parking Violations Agency shall be applicable to all tickets issued for violation of this Article.

§ 202-72. Forfeiture; Civil Penalty. If the Town Clerk shall determine after due investigation and based upon a preponderance of the evidence that a permit holder has sold or otherwise furnished a permit or "visitor pass" granted hereunder to any person other than a "resident" or "visitor" as defined in this article, then the Town Clerk may revoke the permit and any "visitor pass" issued to the permit holder and prohibit the permit holder from obtaining a new permit and/or visitor pass until (a) a civil penalty of \$500 is paid to the Town of Hempstead by the permit holder, and (b) not less than one year has elapsed from the date of the Town Clerk's determination. The Town Clerk may waive or reduce the said one year period on the basis of substantial hardship shown.

§ 202-73. Severability. If any clause, sentence, paragraph, section or part of this Article shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been rendered.
