WHEREAS, pursuant to the terms of the MCDC Initiative, the Enforcement Division will recommend "favorable settlement terms" for issuers and underwriters that self-report by 5:00 p.m., eastern standard time, on December 1, 2014, possible materially inaccurate statements in official statements in the last five years relating to prior compliance with Continuing Disclosure Obligations by submitting a specified questionnaire (the "Questionnaire") to the Enforcement Division; and

WHEREAS, the Town has been provided with a copy of the MCDC Initiative, a copy of a memorandum prepared by the financial advisor to the Town describing the MCDC Initiative, and a copy of the Questionnaire released by the Enforcement Division; and

WHEREAS, if an issuer takes advantage of the MCDC Initiative by self-reporting possible materially inaccurate statements and if any of such statements are determined to be materially inaccurate by the Enforcement Division, the Enforcement Division will recommend to the SEC a settlement in which (i) the issuer consents to a cease-and-desist order, (ii) the issuer neither admits nor denies the findings of the SEC and (iii) there is no payment of any civil penalty by the issuer; and
