WHEREAS, the Town Board, by Resolution No. 981-2012, duly adopted on August 7, 2012, did authorize the acceptance of the bid of Watral Brothers, Inc for asbestos abatement, demolition and site clearance at 25 Ray Street and 326 Clinton Avenue, Roosevelt, New York for the bid price of \$259,000; and

WHEREAS, the scope of the work in the contract between the Town of Hempstead and Watral Brothers, Inc did not include the removal of fallen trees caused by "SuperStorm Sandy", nor did it include the removal of 800 square feet of transite shingle and an illegal sanitary cesspool located at 326 Clinton Avenue, Roosevelt, New York; and

WHEREAS, after the project had commenced, the Town's Project Engineer, Carman-Dunne PC, determined that the removal of the trees, the shingles, and the cesspool was necessary and beneficial to the project, and on or about July 18, 2013, he approved a Change Order in the amount of \$5,000.00 for the removal of fallen trees at 326 Clinton Ave, Roosevelt; on or about July 18, 2013 he approved a Change Order in the amount of \$14,875.00 for the removal of additional fallen trees at 326 Clinton Ave, Roosevelt; on or about May 27, 2014, he approved a Change Order in the amount of \$7,130.00 for the removal of transite shingles at 326 Clinton Ave, Roosevelt; and on or about May 27, 2014, he approved a Change Order in the amount of \$4,830.00 for the removal of an illegal sanitary cesspool at 326 Clinton Ave, Roosevelt; and
