3 relation to "Restricting and Prohibiting
4 "Hookah" facilities or establishments" in the
5 Town of Hempstead.

6 SUPERVISOR GILLEN: I have a number of
7 slips on this matter.

8 First, we have Corinne Alba.

9 Ms. Alba, would you, please, come up
10 and state your name and address for the
11 record.

12 CORINNE ALBA: Corinne Alba. I am
13 here today representing the YES Community
14 Center.

15 We are located in Levittown, Town of
16 Hempstead.

17 And, I am, here, today, just to
18 support this legislation moving forward
19 because what we know in the treatment World,
20 in the substance-abuse World, the earlier,
21 um, kids begin to use substances, whether it
22 is cigarettes, Hookahs, um, the likelihood of
23 addiction is higher.

24 So, today, we are here to help keep
25 faith, families and children safe.

HEMPSTEAD TOWN MEETING 1/9/18

1 So, anything, any legislation that
2 could prevent substance abuse which our
3 community members are young and old.

4 We support any legislation that helps
5 educate community members and prevent early
6 onset of substance abuse.

7 Keeping paraphernalia out of our
8 communities is a strong step in this
9 direction.

10 Therefore, again, we support this
11 legislation moving forward.

12 Thank you.

13 SUPERVISOR GILLEN: Thank you for your
14 comments.

15 Next, we have Felix Procacci.

16 Please, state your name and address
17 for the record.

18 FELIX PROCACCI: Felix Procacci. 1165
19 Barns Street, Franklin Square.

20 First, why is the Town prohibiting the
21 Hookah facilities?

22 TOWN ATTORNEY RA: Mr. Procacci, we
23 are not prohibiting them.

24 We are making them, um, go ahead, I am
25 sorry.

1 Go ahead.

2 COUNCILMAN DUNNE: We are restricting
3 them away from residential areas as was
4 mentioned earlier.

5 FELIX PROCACCI: Restricting and
6 prohibiting them so - -

7 TOWN ATTORNEY RA: They are
8 prohibiting them in certain residences and
9 business districts and going in Industrial Y
10 Districts.

11 We are permitting them in Industrial Y
12 Districts.

13 FELIX PROCACCI: Were any studies done
14 to determine the effect of Hookah facilities
15 on property values?

16 COUNCILMAN DUNNE: Right, now, as you
17 know, smoking hookah for one hour is
18 equivalent to smoking a pack of cigarettes.

19 The Hookah Lounges that are opened
20 right, now, the neighborhood is finding drug
21 paraphernalia in their front yard and aside
22 yards.

23 We don't want it in residential areas.

24 So, the studies are what we hear from
25 the people in our Town of Hempstead right,

1 now.

2 FELIX PROCACCI: Okay, um, yeah, I
3 looked into all of this, um, there is very
4 few studies and actually studies showing
5 there aren't studies on the addiction of the
6 Hookah, you know, that kind of smoking.

7 But, um, regarding what is a matter of
8 you used public comments to come to this
9 conclusion on how to restrict it.

10 COUNCILMAN DUNNE: Not to be in
11 residential areas and all the kids being
12 subjected to the smoke.

13 FELIX PROCACCI: I agree they
14 shouldn't be in residential areas.

15 Just like, you know, the different
16 between this and a bar, I don't want a bar in
17 a residential area either.

18 It is the same, you just are
19 restricting it to Industrial areas, that is
20 all this legislation is?

21 COUNCILMAN DUNNE: Yes.

22 FELIX PROCACCI: Thank you.

23 COUNCILMAN DUNNE: Thank you.

24 SUPERVISOR GILLEN: Donna LaScala?

25 DONNA LaSCALA: To the esteemed

1 Council, my name is Donna LaScala.

2 I am the Director of the East Meadow
3 SMART Coalition located in East Meadow.

4 SUPERVISOR GILLEN: Ms. LaScala, can
5 you just state your address for the record,
6 please.

7 DONNA LaSCALA: Sure.

8 My address is 12 Hick (as heard)
9 Circle, Hicksville.

10 I am not currently living in the Town
11 of Hempstead, but I am representing the
12 Coalition which is in the Town of Hempstead.

13 SUPERVISOR GILLEN: Thank you.

14 DONNA LaSCALA: We are working along
15 with the East Meadow School District,
16 political leaders, business leaders and
17 community leaders to combat the drug abuse
18 problem in our youth.

19 And, I am glad the heroin and opioid
20 problem is starting to get some recognition.

21 We really do need to pay more
22 attention to this issue of vaping drugs like
23 nicotine and alcohol.

24 And, the Hookah Lounges and vaping are
25 rising in use and posing a great health risk.

HEMPSTEAD TOWN MEETING 1/9/18

1 The Center for Disease Control and
2 Prevention reports that Hookah smoke carries
3 many of the same health issues and risk as
4 traditional cigarette smoking, oral cancer,
5 lung cancer, stomach cancer, esophageal
6 cancer.

7 Hookah smoke delivers nicotine, but it
8 also contains smoke from a heat source which
9 is, um, latent with carbon monoxide and other
10 toxic carcinogens.

11 This is very dangerous for second-hand
12 recipients.

13 In addition, as Councilman Dunne said,
14 traditional smokers take an average of twenty
15 puffs to finish a cigarette.

16 An hourlong Hookah session involves
17 two hundred puffs from a mouth piece with
18 several participants.

19 This is a health hazard, to clarify
20 the gravity of the situation.

21 I want to bring some specifics in, um,
22 East Meadow, we, currently have sixteen
23 hundred ninety-two municipal students and two
24 thousand and two hundred and seventy-nine
25 High School students in the School District.

HEMPSTEAD TOWN MEETING 1/9/18

1 The CDSC reported in 2016 that 7.2 percent
2 of the Middle Schoolers and 20.2 percent of
3 the High School students reported they are
4 using some type of tobacco product.

5 And, also, two percent of the Middle
6 Schoolers and 4.8 percent High School
7 students reported using Hookah in the last
8 thirty days.

9 So, if you look at the Hookah use over
10 a thirty-day period of time, that means that
11 thirty-four kids from Clarke and Brooklyn
12 Middle School combined and one hundred and
13 nine kids from East Meadow High School and
14 Clarke High School combined are visiting
15 Hookah lounges.

16 Um, this is also present in Colleges
17 students - - twenty-two - - some were
18 between twenty-two and forty percent of
19 college students are going to Hookah Lounges.

20 Now, we have several, um, Colleges in
21 our Community; Hofstra, Molloy, Adelphi,
22 Nassau Community College, that is about forty
23 thousand students in those four Colleges.

24 So, if I look at twenty-two to forty
25 percent, that is somewhere between eight

1 thousand and sixteen thousand kids between
2 the ages of eighteen and twenty-one going to
3 Hookah Lounges.

4 Honestly, we made it just too easy for
5 them.

6 The Cazpa (phonetic spelling) is
7 located at 2051 Hempstead Turnpike, that is
8 within walking distance of East Meadow High
9 School.

10 The Mystique Lounge is at 9073 Old
11 Country Road is easily reached by Park
12 students and Scorpion is conveniently placed
13 between Hofstra and NCC and that is at 723
14 Fulton Avenue.

15 So, we can point the finger at the
16 manufacturer of these non-tobacco products
17 because they make it so attractive to kids
18 with flavors like apple, mint, cherry,
19 chocolate and watermelon or we can take a
20 good look at ourselves and realize we need to
21 be part of a solution and not part of the
22 problem.

23 And, on behalf of the Coalition, I
24 would like to endorse Councilman Dunne's
25 initiative to limit Hookah Lounges

1 and limit their proximity to schools.

2 Thank you very much.

3 COUNCILMAN DUNNE: Thank you.

4 SUPERVISOR GILLEN: Thank you.

5 Is there anybody else that wishes to
6 be heard on this?

7 Oh, wait, I am sorry, one more slip,
8 County Legislator John Ferretti.

9 Legislator, would you, please, state
10 your name and address for the record.

11 NASSAU COUNTY LEGISLATOR FERRETTI:

12 Sure.

13 John Ferretti. 76 Ridge Lane,
14 Levittown.

15 Good Evening, Supervisor.

16 SUPERVISOR GILLEN: Good Evening.

17 NASSAU COUNTY LEGISLATOR FERRETTI:

18 Congratulations.

19 SUPERVISOR GILLEN: Thank you.

20 You, as well.

21 NASSAU COUNTY LEGISLATOR FERRETTI:

22 Thank you so much.

23 I am here, today, in support of this
24 initiate in Levittown.

25 As Councilman Dunne is well aware

1 we have a Hookah Lounge that was proposed,
2 um, on the corner of Wilcox Lane and
3 Hempstead Turnpike and they actually opened
4 without building permits.

5 And, the Town has done a good job in
6 closing them down, but I fully support this
7 legislation as Councilman Dunne is well
8 aware.

9 I have given him some input on this,
10 as well.

11 Um, we have a severe problem, not just
12 in Levittown, not just in the Town of
13 Hempstead, but, really, throughout the State
14 of New York with the opioid epidemic that you
15 are all dealing with.

16 People don't realize that the Hookah -
17 - smoking hookah is just as harmful as
18 smoking cigarettes and sometimes even worse
19 because while you may smoke cigarettes, the
20 whole business model of Hookah Lounges is a
21 social environment where you are sharing this
22 Hookah pipe and taking two hundred hits, I
23 will call it, of this Hookah pipe.

24 With a single cigarette, you can smoke
25 with far fewer.

1 This is something that does not have
2 an odor like cigarettes does.

3 It is something that, as a parent,
4 really can't detect on your child.

5 And, so, it is so important that we
6 nip this in the bud right, now.

7 And, I ask that you all support
8 Councilman Dunne's legislation.

9 Councilman, I really thank you for all
10 the work you put in on this and I fully
11 support it.

12 Thank you so much.

13 SUPERVISOR GILLEN: Is there anybody
14 else that wishes to be heard on this item?

15 Please, come forward.

16 State your name and address for the
17 record.

18 JANE FINKELSTEIN: Congratulations.

19 SUPERVISOR GILLEN: Thank you.

20 JANE FINKELSTEIN: Jane Finkelstein.

21 848 Mayer (as heard) Drive, Wantagh, New
22 York.

23 As a parent representing the Levittown
24 Community Action Coalition, we are dedicated
25 to helping keep our community safe.

HEMPSTEAD TOWN MEETING 1/9/18

1 Um, there is representation by all
2 sectors of our community; the schools, the
3 churches, the businesses and the students, as
4 well.

5 As recently as today, this morning, we
6 discussed concerns about the presence of
7 these establishments in our community.

8 Um, they should not be in residential
9 areas where there are so many children, so
10 many schools.

11 Today, we had a meeting where we had
12 students through our School District and I
13 can tell you, every single topic of
14 conversation of these children were, in terms
15 of vaping, of drug paraphernalia and what not
16 having any place in the Town of Hempstead, my
17 community, to go to, which results to this
18 type of behavior.

19 So, we surely do not need one on our
20 corners right where we live.

21 So, I greatly appreciate, as a parent,
22 that this is strongly considered, and this
23 legislation is passed with these
24 establishments are not in residential
25 neighborhoods.

1 Thank you.

2 SUPERVISOR GILLEN: Thank you.

3 Is there anybody else that wishes to
4 be heard?

5 Please, come forward.

6 State your name and address for the
7 record, please.

8 RICHARD SCHURIN: Good Evening.

9 Richard Schurin. 167 Jefferson
10 Avenue, Island Park, New York.

11 Congratulations.

12 SUPERVISOR GILLEN: Thank you.

13 RICHARD SCHURIN: I support this
14 measure, but I have some questions regarding
15 the legality of it.

16 What is the definition of a Hookah
17 Lounge?

18 SUPERVISOR GILLEN: Mr. Ra, can you
19 help us on that one.

20 TOWN ATTORNEY RA: I have to tell you
21 that I really don't know, um, exactly, what
22 it is.

23 But, it is a premises where people go
24 to smoke large, I guess they call them,
25 "hookahs" and, um, and so, I am not one

1 hundred percent sure.

2 I apologize.

3 RICHARD SCHURIN: Really, my question
4 is - -

5 TOWN ATTORNEY RA: You know it when
6 you see it.

7 RICHARD SCHURIN: I know what a Hookah
8 Lounge is, what is the difference of a Hookah
9 Lounge in this proposed law if hookahs are
10 present and used in bars or they are used in,
11 um, cigar shops, for example, which I know
12 they exist in, um, how do you define a Hookah
13 Lounge under this law?

14 Has there been any attempt to do that?

15 COUNCILMAN BLAKEMAN: Can I jump in.

16 Basically, a Hookah Lounge, as our
17 Town Attorney stated, is a place where people
18 congregate, smoke the material, has excessive
19 amounts of nicotine where they share the same
20 pipe which is obviously a major health
21 concern aside from the nicotine.

22 It is the same thing, you know, you
23 can't have a bar in certain areas, near a
24 school, so, a bar is a bar.

25 A Hookah Lounge is a Hookah Lounge.

HEMPSTEAD TOWN MEETING 1/9/18

1 I don't see that as an issue.

2 RICHARD SCHURIN: All Hookah Lounges
3 in the rear would be permitted?

4 COUNCILMAN BLAKEMAN: No.

Page | 22

5 RICHARD SCHURIN: So, any
6 establishment, if it is predominately a bar
7 or cigar shop, it happens to also have Hookah
8 facilities, which I know places exist, do you
9 understand that would be prohibited?

10 COUNCILMAN DUNNE: The legislation
11 states that various hookah bars, hookah
12 lounges, hookah services, established
13 lawfully and actually operating right, now,
14 will continue to be open.

15 We are not going to close anybody
16 down.

17 It is preventing anybody from opening
18 a new one like someone spoke about earlier
19 and they want to open in Levittown on
20 Hempstead Turnpike, all around it and kids
21 constantly in the area there.

22 This is not acceptable.

23 And if you want to do something in
24 your home, that is fine.

25 You cannot do it in public.

HEMPSTEAD TOWN MEETING 1/9/18

1 We don't want the kids and even young
2 adults that are impressionable to have this
3 in residential areas.

4 If you want to enjoy it and do it, you
5 can go to the City or go to Industrial areas
6 where it is allowed, and they will open
7 there.

8 RICHARD SCHURIN: I am not nitpicking.

9 I am recommending that you define what
10 Hookah Lounge is to make sure that this law
11 is enforceable.

12 TOWN ATTORNEY RA: It is an
13 establishment that has - -

14 SENIOR COUNCILWOMAN GOOSBY: No, I
15 know what a Hookah Lounge is.

16 I did see one and I visited one, so,
17 that is why I know what it is.

18 It is a large area where you guys go
19 to smoke pipes.

20 It is a large piece of equipment that
21 they use with different tobacco and different
22 smells in it and they sit there and smoke.

23 And, the smoke is all over the place.

24 So, that is what they do.

25 It is not just one.

1 It is three or four different pipes
2 or more that they use to smoke.

3 COUNCILMAN D'ESPOSITO: If I may, I
4 think Mr. Sherman's questions is how are we
5 going to differentiate between a hookah bar
6 standing alone and a hookah bar that maybe
7 involved in another premises, is that
8 correct?

9 RICHARD SCHURIN: Yeah, a hookah being
10 involved in any premises.

11 TOWN ATTORNEY RA: What the law
12 states, it has, if it is in a facility that
13 has, as the primary accessory or ancillary
14 use smoking tobacco or other substances
15 through hookah pipes, either single or multi
16 use and so, there are different types of
17 hookah pipes and, um, there is also something
18 called a water pipe, a shisha pipe, so that
19 and so it is clubs that have these types of
20 facilities and has as its primary or
21 ancillary or accessory use facilities where
22 people can be in lounges, cabarets or, um,
23 bars which have as their primary use smoking
24 those substances.

25 RICHARD SCHURIN: Thank you.

HEMPSTEAD TOWN MEETING 1/9/18

1 My last question; has the Town
2 received a legal opinion from anyone as to
3 the legality of the law?

4 TOWN ATTORNEY RA: The law was patent
5 after the laws in other municipalities and we
6 are confident it would be upheld.

7 RICHARD SCHURIN: Thank you.

8 SUPERVISOR GILLEN: Is there anybody
9 else that wishes to be heard on this time?

10 (Whereupon, no response was heard.
11 After, the following ensued.)

12 COUNCILWOMAN DUNNE: I make a Motion
13 to close the Hearing and move on the item, to
14 adopt the item.

15 SENIOR COUNCILWOMAN GOOSBY: I second
16 the Motion.

17 SUPERVISOR GILLEN: Madam Clerk, would

21 They are watching these hires and they
22 are going to be the ones to decide in two
23 years that the Republicans, based on their
24 conduct, are not coming back.

8 actually voted against her appointment to
9 Occupational Resources and I voted against
10 everybody's appointment because I thought we
11 should go through them one by one and not
12 rush to judgment.

13 So, um, I do have a record of voting
14 against that.

15 However, in this particular
16 circumstance, I have had time to consider her
17 appointment as Deputy Commissioner and, um,
18 she is a capable person.

19 She is experienced in Town government.

20 She is well experienced in Town
21 government and although she and I have had
22 our differences in the past, the reality is
23 that I do think that she is capable.
