2	Chris is the Project Civil Engineer. I
3	also have with me, here, today, Harry Singh is
4	with us, also and Andrew Villari from Stonefield $^{Page 12}$
5	Engineering.
6	Andrew is an engineer licensed in the State
7	of New York and is our traffic consultant.
8	And, finally, I have with me, today, John
9	Breslin from Breslin Appraisals who has prepared a
10	real estate report and will be submitting them
11	into the record, as well.
12	Um, just to run through the application
13	briefly, the property which is 1111 Hempstead
14	Turnpike, Franklin Square, New York, also known by
15	Nassau County Tax Map as Number Section 35,
16	Block 15504.
17	It is situated on the southwest corner of
18	Hempstead Turnpike and Scherer Boulevard.
19	It is noted in the property which is
20	irregularly shaped and if you look at the video
21	screens to both our right and left, you will note
22	that the gas station is on the easterly portion of
23	the site fronting along Hempstead Turnpike and
24	Scherer Boulevard.
25	Then you will see a lot swath in green,

1	sort of a thumb that sticks out among the
2	residential developments to our, um, South there
3	and that is under developed and I will state for
4	the record, right, now, it is the Applicant's $Page \mid 13$
5	intention to leave it undeveloped.
6	We will not be developing in any part of
7	that sort of thumb, again, that extends to the
8	residential zoning district and if you, again,
9	look at the video display screens, you will see
10	that everything is kept on the easterly part of
11	the site closer to, again, Hempstead Turnpike
12	within the area of the service of the existing
13	development. For the most part

24	There will be five fuel dispensers

2	ninety square feet vacuum and air station removed
