3	Welcome to the latest installment of the
4	Budget Hearing. Page   3
5	This is a Special Meeting of the Hempstead
6	Town Board.
7	Since this is a Special Meeting, there will
8	be no Administrative Calendar.
9	There will be Public Comment at the
10	conclusion of the Meeting.
11	There is a meeting agenda available in the
12	rear of the Pavilion.
13	If you want to be heard on the budget, fill
14	out a slip which maybe obtained from the Public
15	Safety Officer.
16	Because this is a continuation of the prior
17	Budget Hearing, you already have been heard on the
18	budget, you will not be called up to speak again,
19	except to the extent I just been handed an
20	amendment.
21	If you have already addressed the Town
22	Board on the Budget, generally, you may speak
23	today on the amendment.
24	Madam Clerk, will you, please, call the
25	roll.

1	CLERK CABANA: Supervisor Gillen?
2	SUPERVISOR GILLEN: Here.
3	CLERK CABANA: Councilman Blakeman?
4	COUNCILMAN BLAKEMAN: Here. Page   4
5	CLERK CABANA: Councilman D'Esposito?
6	COUNCILMAN D'ESPOSITO: I am here.
7	CLERK CABANA: Councilman Dunne?
8	COUNCILMAN DUNNE: Here.
9	CLERK CABANA: Senior Councilwoman Goosby?
10	SENIOR COUNCILWOMAN GOOSBY: Here.
11	CLERK CABANA: Councilman Muscarella?
12	COUNCILMAN MUSCARELLA: Here.
13	SUPERVISOR GILLEN: I, now, ask Councilman
14	D'Esposito to lead us in the Pledge of Allegiance.
15	COUNCILMAN D'ESPOSITO: With your hand over
16	your heart, I pledge
17	(Whereupon, Councilman D'Esposito led the
18	Assembly in the Pledge of Allegiance. After, the
19	following ensued.)
20	SUPERVISOR GILLEN: Madam Clerk, will you
21	call the Public Hearing, please.
22	CLERK CABANA: Preliminary Budget, Town of
23	Hempstead for the fiscal year beginning January 1,
24	2020.
25	SUPERVISOR GILLEN: Do we have any motions

1	or proposed amendments to the Budget?
2	COUNCILMAN D'ESPOSITO: Yes, I move to
3	amend the Preliminary Budget by reducing the
4	salaries and wage amounts of the Town Board $Page \mid 5$
5	Majority, the Supervisor's Office, the Receiver of
6	Taxes and the Town Clerk's Office and by reducing
7	the tax levy of the Town of Hempstead Refuse
8	Disposal District as shown in this amended
9	resolution.
10	Copies of which are, now, being distributed
11	to the Board and the Public.
12	SUPERVISOR GILLEN: May I have a Motion on
13	the amendment.
14	SENIOR COUNCILWOMAN GOOSBY: I second the
15	Motion.
16	SUPERVISOR GILLEN: Madam Clerk, please,
17	call the roll on the amendment.
18	CLERK CABANA: Supervisor Gillen?
19	SUPERVISOR GILLEN: Since I have been
20	handed this amendment, um, and it seems to be
21	disproportionately I just have been handed
22	this amendment.
23	I asked for it. There was a Press
24	Conference about it this morning.
25	We asked for a copy of it but I was not

1	given it until right, now, so, I have to vote no
2	against this amendment because I haven't had a
3	chance to read it and it seems to target my office
4	disproportionately, which has a budget about $1.7^{ extst{Page} 6}$
5	million dollars less than the Town Council, even
6	though collectively we represent the same amount
7	of people.
8	And, it also seems to targeted at part-
9	timers who receive no benefits.
10	I don't know if there are people, here that
11	are going to be impacted on the Tozner list.
12	So, I vote no on this.
13	CLERK CABANA: Councilman Blakeman?
14	COUNCILMAN BLAKEMAN: I vote aye.
15	SENIOR COUNCILWOMAN GOOSBY: This is on the
16	amendment.
17	COUNCILMAN BLAKEMAN: I vote aye.
18	CLERK CABANA: Councilman D'Esposito?
19	COUNCILMAN D'ESPOSITO: Aye.
20	CLERK CABANA: Councilman Dunne?
21	COUNCILMAN DUNNE: Aye.
22	CLERK CABANA: Senior Councilwoman Goosby?
23	SENIOR COUNCILWOMAN GOOSBY: Aye.
24	CLERK CABANA: Councilman Muscarella?
25	COUNCILMAN MUSCARELLA: Aye.

1	SENIOR COUNCILWOMAN GOOSBY: I don't think
2	as far as I know, the part-timers are not targeted
3	on this new Resolution, Supervisor.
4	SUPERVISOR GILLEN: Okay, I have slips. $\overset{ ext{Page}}{ ext{I}} 7$
5	have a slip from Diane Madden.
6	Ms. Madden, you have already been heard on
7	the budget, if you like to speak on the amendment,
8	you are welcomed to.
9	(Whereupon, "no thank you," was heard
10	calling out from the audience. After, the
11	following ensued.)
12	SUPERVISOR GILLEN: Stuart Kroll? I
13	believe you have already spoken on the Budget.
14	Laura Wiggens?
15	SENIOR COUNCILWOMAN GOOSBY: Come up if you
16	want to speak.
17	SUPERVISOR GILLEN: Just have a seat and
18	state your name and address for the record before
19	you start speaking, Ms. Wiggens.
20	LAURA WIGGENS: Okay, pardon me, this is
21	the first time that I have addressed the Board,
22	so, I am a little nervous.
23	SUPERVISOR GILLEN: Don't be nervous.
24	LAURA WIGGENS: The name is Laura L.
25	Wiggens. I reside at 1051 Jerusalem Avenue,

1	Uniondale, New York.
2	Okay, and, I would like to make a few
3	comments on the Uniondale Public Library Budget.
4	First of all, I know that every $Page \mid 8$
5	organization has to have a budget, but, the budget
6	should be formed in a manner that is, shall we
7	say, aiding the business and Uniondale Public
8	Library is a business.
9	There is only one problem, there is no head
10	of the Uniondale Public Library.
11	The last Director of the Uniondale Library
12	was in 2014.
13	Since, then, those that came to get
14	experience, number 3 or 4, they did not come in
15	with the title of "Director," they came in with
16	the title such as "Purchasing Agent."
17	They left in a few months after acquiring
18	what they needed to move on.
19	At present, there is no Director at
20	Uniondale Public Library.
21	The Board which governs, in my humble
22	opinion, has done a poor job.
23	For example, they have spent one hundred
24	and thirty-seven thousand dollars to refurbish
25	four bathrooms; two have baby tables.

1	The bathrooms took two and a half years to
2	be refurbished.
3	Two weeks ago, there was a flood in the
4	bathrooms which went into the auditorium. Page $\mid$ 9
5	The auditorium was closed for two and a
6	half years, about seven years ago, because it is
7	sitting on a water table.
8	The Board wished to expand in the Library.
9	They can't do that.
10	Why?
11	They are sitting on a water table.
12	Second flood in the auditorium has caused
13	an unhealthy condition; mold in the auditorium, at
14	present where once the blue carpet is, now, blue
15	and orange.
16	(Whereupon, the three-minute bell rang.
17	After, the following ensued.)
18	LAURA WIGGENS: If I may
19	SUPERVISOR GILLEN: If you could try to
20	wrap up your comments.
21	LAURA WIGGENS: Yes, I am going to.
22	The Board was presented with a petition
23	from the community asking for a particular party
24	who has worked diligently in the community for
25	over fifteen years has written grants, secured

1	Grants, has written, um, what is it?
2	Has written for, has presented oh, my
3	goodness has secured Grants for the Library.
4	. Page $\mid 10$ Um, the position of Assistant Director, she
5	was not considered for it, although the signatures
6	were over three hundred.
7	Now, what I am saying to you
8	SUPERVISOR GILLEN: Just wrap it up.
9	LAURA WIGGENS: I am going to wrap it up
10	real fast.
11	What I am saying is this, how can you
12	adopt, okay, permits, a group of individuals who
13	have been negligent in taking on their fiduciary
14	responsibility.
15	There is no Director.
16	There is no audit.
17	You have a one line which gives a total
18	cost of salaries.
19	SUPERVISOR GILLEN: Okay.
20	LAURA WIGGENS: That is not permissible.
21	SUPERVISOR GILLEN: Ms. Wiggens, I am sorry
22	
23	LAURA WIGGENS: I ask you, please, what is
24	needed is a forensic audit on the Uniondale Public
25	Library and the budget is to be frozen with

1	Supervision since the Town of Hempstead is the
2	SUPERVISOR GILLEN: Thank you, Ms. Wiggens.
3	You already gone over your three minutes.
4	I have kept other people to three minutes,
5	so, thank you.
6	The Uniondale Public Library budget, Mr.
7	Longobardo, can you explain to Ms. Wiggens, we
8	don't prepare that budget.
9	DEPUTY COMPTROLLER LONGOBARDO: As the
10	Supervisor said, the Town does not prepare the
11	budget.
12	The budget is prepared by the Board of the
13	Uniondale Public Library.
14	And, they have control over expenses.
15	They have control over hiring of the
16	Director.
17	So, unfortunately, while you bring those
18	issues to us, um, the issues you raised have to be
19	addressed to the Board of the Library.
20	LAURA WIGGENS: The Board will not address
21	it since the Town is the overseer for the hamlet
22	of Uniondale, that is why I am here because we can
23	go to the Board and the Board will turn their
24	heads, then, they present a budget, but the budget
25	is not presented

1	SUPERVISOR GILLEN: I am sorry. I have to
2	call up the next speaker.
3	We can continue this discussion afterwards.
4	I have your contact information.
5	Patrick Keating?
6	PATRICK KEATING: Good Evening.
7	SUPERVISOR GILLEN: Good Evening.
8	PATRICK KEATING: Patrick Keating, Baldwin
9	resident.
10	I have three topics for discussion, real
11	quick; the first one, if I could ask in the
12	budget, where can we locate, specifically, the
13	actual cash amounts that are set aside for the
14	Overlay project within Baldwin?
15	I can't seem to find it outlined.
16	With that being said, (A) how much is
17	available to date?
18	And, (B) does this include the ten million
19	dollars that the Governor provided to us?
20	SUPERVISOR GILLEN: The ten million dollars
21	is a completely separate Grant.
22	It is not part of our budget.
23	PATRICK KEATING: Okay, (2) within sixty
24	days to meet FEMA requirements for the corrective
25	action for the Town of Hempstead Building

1	Department; (A) how much will that cost to meet
2	this requirement?
3	(B) once submitted, what is included in
4	estimated total dollars for that. $ Page \mid 13 $
5	And,(C) if you do not meet the FEMA
6	requirements within those sixty days, what is your
7	back-up plan to date?
8	SUPERVISOR GILLEN: So, we have been
9	working with FEMA, actually, my office reached out
10	to bring FEMA back to close out their community
11	assistance visit.
12	Um, that is not part of the budget process,
13	but, I would be happy to follow-up with you and
14	answer all your questions.
15	We are trying to keep the discussion today
16	on the budget.
17	We already started taking some ameliorative
18	actions to address some of the concerns of FEMA.
19	And, I would be happy to talk to you about
20	them offline.
21	I think I have your contact information.
22	PATRICK KEATING: Yes.
23	SUPERVISOR GILLEN: Okay, so, we will
24	follow-up with you afterwards, okay, Mr. Keating?
25	PATRICK KEATING: And, lastly, with

1	your multi-year capital plan, have you been able
2	to refinance any of the debt from the Town of
3	Hempstead?
4	SUPERVISOR GILLEN: Yes, we have
5	consistently refinanced debt as it became eligible
6	to refinance and we saved millions of dollars.
7	PATRICK KEATING: Who was that through?
8	SUPERVISOR GILLEN: What was that?
9	Who are we using to refinance the debt?
10	DEPUTY COMPTROLLER LONGOBARDO: It goes out
11	to bid.
12	PATRICK KEATING: Who took it this time?
13	I was wondering, do you know?
14	SUPERVISOR GILLEN: If we don't have that
15	information, we will let you know, sir.
16	I will get back to you.
17	SENIOR COUNCILWOMAN GOOSBY: Give him a
18	chance to give it to you, sir.
19	We made pretty good money on it too.
20	PATRICK KEATING: Yeah?
21	SENIOR COUNCILWOMAN GOOSBY: So, we saved
22	some money for the Town this year.
23	PATRICK KEATING: Correct, especially, for
24	Baldwin, who is at stake of maybe losing some
25	money.

1	SENIOR COUNCILWOMAN GOOSBY: Hold on, he is
2	getting you the information.
3	DEPUTY COMPTROLLER LONGOBARDO: We will get
4	it for you. We thought we had it.
5	PATRICK KEATING: Have a good evening.
6	SUPERVISOR GILLEN: Thank you, sir.
7	Lucille Defina?
8	(Whereupon, no response was heard. After,
9	the following ensued.)
10	SUPERVISOR GILLEN: Felix Procacci?
11	And, this is just on the amendment.
12	FELIX PROCACCI: Felix Procacci.
13	Um, first, the most important thing before
14	you even get to the amendment, this meeting
15	illegal.
16	The amendments were not provided on the
17	website prior to the meeting per the Open Meetings
18	Law, New York State Meetings Law, which I provided
19	at the last meeting.
20	I have mentioned this a dozen times.
21	In addition, they weren't provided even at
22	the door when I walked in.
23	I literally got them minutes before the
24	meeting started.
25	So, this meeting is illegal.

1	And, I emphasize to the Press, please,
2	write this because they are all lawbreakers, here,
3	all of them.
4	Page $\mid$ $16$ Right, here, you are looking at them. They
5	are all lawbreakers and the Parliamentarian,
6	there, Joe Ra, he goes a long with it.
7	He should step up and say this is illegal
8	but he doesn't do that because he doesn't care
9	about the law.
10	He is a lawyer. The Town Attorney does not
11	care about the law.
12	Now, can you explain each of these bullet
13	points?
14	Because I don't have the time, I only have
15	a few minutes to look up each of these Codes and
16	look at the percentages.
17	Can someone tell me what these are?
18	SUPERVISOR GILLEN: Can you explain these,
19	Bruce?
20	It is your amendment, right?
21	COUNCILMAN D'ESPOSITO: Mr. Mastromarino?
22	COUNCILMAN BLAKEMAN: Basically, we heard
23	from people, they wanted us to come back,
24	especially on, um, staffing, Town Council and all
25	the elected officials cutting our own staff,

1	cutting the Supervisor's Office.
2	We are cutting the Receiver of Taxes. We
3	want to have additional savings, tax cuts for the
4	taxpayers of the Town of Hempstead. Page   17
5	So, um, I found a way to do that.
6	And, Felix, I think you would realize this.
7	FELIX PROCACCI: I can't see what this is.
8	CONSULTANT MASTROMARINO: John
9	Mastromarino. 240 Fletcher Avenue, Valley Stream,
10	New York.
11	The changes are in the Town Board Majority
12	reducing fulltime wages, two hundred and fifty-six
13	thousand six hundred and fifty-one dollars.
14	Reducing part-time wages
15	FELIX PROCACCI: That is something I
16	don't have that.
17	CONSULTANT MASTROMARINO: You are asking me
18	for the details, I am giving it to you.
19	FELIX PROCACCI: Yeah, the details, tell me
20	what each of these are?
21	I don't know what you are reading, what is
22	this one?
23	CONSULTANT MASTROMARINO: The difference,
24	these items are reduced in the budget.
25	You have to give what the budget is

1	showing, now, which is two million one sixty-four,
2	four twenty-two and what it is going to be reduced
3	to.
4	It is going to be reduced to one million $^{ ext{Page} 18}$
5	nine zero seven, seven one.
6	By the elimination of fulltime wages and
7	part-time wages in the Town Board Majority.
8	These are the Codes in the Bud get.
9	FELIX PROCACCI: I understand.
10	What positions are being eliminated?
11	CONSULTANT MASTROMARINO: There are two
12	positions; Executive Assistant to the Town Board
13	and one Legislative Aide and part-time, twenty-
14	five thousand dollars.
15	FELIX PROCACCI: Okay, then, the next one?
16	CONSULTANT MASTROMARINO: The next one in
17	the Supervisor's budget is reducing fulltime
18	wages, two hundred and sixty-five thousand
19	dollars.
20	It represents a Special Assistant to the
21	Supervisor and Executive Assistant to the
22	Supervisor.
23	And, that is your from and to numbers that
24	you are reading.
25	Going to the others; in the Receiver of

1	Taxes and the Town Clerk
2	FELIX PROCACCI: Wait, wait, you are going
3	ahead.
4	Did you talk about this one, yet? Page   19
5	(INDICATING)
6	CONSULTANT MASTROMARINO: Yes, that is
7	twenty-five thousand dollar reduction in part-time
8	wages.
9	See the fifty-five thousand dollars?
10	FELIX PROCACCI: I can read numbers but I
11	just don't know what positions you are actually
12	cutting?
13	CONSULTANT MASTROMARINO: I am telling you
14	part-time wages; twenty-five thousand dollars.
15	FELIX PROCACCI: This one over, here, what
16	is this one?
17	CONSULTANT MASTROMARINO: That is one
18	hundred and forty-four thousand, seventeen twenty
19	to forty-four thousand, so, that is a reduction.
20	FELIX PROCACCI: I can read numbers, sir.
21	SUPERVISOR GILLEN: He wants to know what
22	the Code means, what the Code means.
23	CONSULTANT MASTROMARINO: I have to take
24	out the budget and take a look.
25	SUPERVISOR GILLEN: Why don't you

1	take out the budget and take a look.
2	SENIOR COUNCILWOMAN GOOSBY: You know what
3	it is, all it is, is the same ones that we had
4	before and all he is doing is taking more money $^{ extsf{Page} 20}$
5	from them that is it, what you had when we got the
6	first one.
7	It is the same ones except reducing it a
8	little more.
9	SUPERVISOR GILLEN: Is there anybody that
10	can explain what the Codes are if Mr. Mastromarino
11	can't do it?
12	Could you, please, tell Mr. Procacci what
13	the Codes are?
14	SENIOR COUNCILWOMAN GOOSBY: That is not
15	nice. He can do it.
16	DEPUTY COMPTROLLER CAPOBIANCO: The 1330
17	Code is the Receiver of Taxes part-time wages.
18	SENIOR COUNCILWOMAN GOOSBY: That is what
19	he is telling him.
20	DEPUTY COMPTROLLER CAPOBIANCO: It is the
21	Receiver of Taxes, part-time wages.
22	CONSULTANT MASTROMARINO: That is what I
23	told you.
24	DEPUTY COMPTROLLER CAPOBIANCO: The next
25	one is Town Clerk, that is 1410 Code.

1	It is part-time wages, again, 341849 to
2	249839.
3	COUNCILMAN D'ESPOSITO: Thank you, Mr.
4	Capobianco for confirming everything Mr. $Page \mid 21$
5	Mastromarino just said.
6	FELIX PROCACCI: The problem I see, the
7	Receiver of Taxes, part-time wages, you go back in
8	history and you look how much the Receiver of
9	Taxes, the budget has grown since Don Clavin has
10	been the Receiver of Taxes, his budget has gone up
11	eighty percent while the taxes have gone up
12	according to the numbers I got, fifty-four
13	percent.
14	And, the Supervisor's budget has gone up
15	about fifty percent in rough numbers, now, you're
16	taking a big chunk of money out of the
17	Supervisor's budget but you are not doing the same
18	thing for the Receiver of Taxes' budget, that is
19	why I wanted you to detail this out.
20	This is a lopsided thing and you can tell
21	because Supervisor Gillen said so.
22	You didn't even consult her office, so, I
23	don't understand how you do a budget without
24	consulting the people that you are going to
25	affect

1	How would you like it if someone cut your
2	budget without even telling you what they are
3	going to cut out of your budget?
4	That is not the way you do things. Page $\mid$ 22
5	This meeting is illegal.
6	This meeting is illegal.
7	These numbers should have been put up on
8	the website prior to the previous meetings.
9	COUNCILMAN D'ESPOSITO: Felix, you are
10	asking how our people cut wages without people
11	know, it is exactly what the Supervisor did.
12	FELIX PROCACCI: You are cutting a
13	Department Head, a Department's wages without
14	consulting the Head.
15	SENIOR COUNCILWOMAN GOOSBY: Listen
16	COUNCILMAN D'ESPOSITO: It is exactly what
17	the Supervisor did when she put forth her budget.
18	There were Commissioners that didn't know
19	that people were cutting
20	SUPERVISOR GILLEN: There were discussion
21	with every Commissioner.
22	COUNCILMAN D'ESPOSITO: Okay, I bet if we
23	brought every Commissioner up, here, they would
24	say definitely.
25	FELIX PROCACCI: I will just tell you

1	right, now
2	COUNCILMAN D'ESPOSITO: I am going to tell
3	you right, now, you had no problem when that was
4	the case when the budget was originally presented $^{ m Page} 23$
5	but, now, we are presenting numbers, today,
6	cutting from, not only the Receiver of Taxes, not
7	only the Town Clerk, but the Supervisor and the
8	Majority on the Town Board.
9	FELIX PROCACCI: Like I said, it is so
10	lopsided.
11	It is not funny.
12	(Whereupon, the three-minute bell rang.
13	After, the following ensued.)
14	COUNCILMAN BLAKEMAN: No, it is not. We
15	are cutting more from the Majority than we are
16	from the Supervisor.
17	How do you say that is lopsided?
18	We are following the lead that you gave us.
19	SUPERVISOR GILLEN: It is not accurate.
20	FELIX PROCACCI: You are not accurate.
21	Listen to this
22	SENIOR COUNCILWOMAN GOOSBY: Excuse me
23	FELIX PROCACCI: I will leave after this.
24	SENIOR COUNCILWOMAN GOOSBY: Excuse me, you
25	shouldn't allow him to talk.

1	FELIX PROCACCI: The Town Board passed a
2	resolution changing the budget before they changed
3	the budget right, now, all these things, like
4	part-time wages, you hire part-timers without Page   24
5	resolutions.
6	So, you can put all this money back and the
7	public will never know, even if they read the
8	resolution at every meeting.
9	COUNCILMAN BLAKEMAN: Are you for the four
10	percent tax cut?
11	FELIX PROCACCI: I am not for this kind of
12	protocol.
13	I sent an email to you, all of you right
14	after that meeting when I suggested cutting the
15	executive things, which I agree with.
16	I said you all should work together, that
17	is what I said, too.
18	You want to cherry pick what I say. I want
19	you guys to work together.
20	To cut someone's budget without consulting
21	them, that is dead wrong.
22	You can say whatever you want, it is wrong.
23	And, this meeting is wrong because you
24	didn't present it to the public prior to the
25	meeting.

1	You didn't put it on the website prior to
2	the meeting.
3	SENIOR COUNCILWOMAN GOOSBY: What about the
4	fact, listen, we have to do something. $Page \mid 25$
5	We didn't even know that we were losing 3.
6	8 million dollars until the day we were, here.
7	SUPERVISOR GILLEN: Wilhelmina Funderburke?
8	WILHELMINA FUNDERBURKE: Good evening.
9	SUPERVISOR GILLEN: Good Evening, Ms.
10	Funderburke, if you would state your name and
11	address for the record.
12	WILHELMINA FUNDERBURKE: Wilhelmina
13	Funderburke. 156 East Clinton Avenue, Roosevelt,
14	New York, over fifty years.
15	The first thing to start with is that it is
16	very unfair to the young lady that was up, here,
17	speaking and you kept telling her, stopping her
18	and telling her, her time was up when the
19	gentleman came, I was watching that clock, his
20	time started over, you didn't say one word.
21	SUPERVISOR GILLEN: I believe he kept
22	speaking because people were asking him questions
23	and he was responding.
24	WILHELMINA FUNDERBURKE: No, I was sitting
25	right, here.

1	I didn't have a hearing aid and I heard it,
2	that is not fair.
3	If you are going to do it for one, you have
4	to do it for everybody or don't do it. $\overline{ ext{Page} 26}$
5	SUPERVISOR GILLEN: That is why I try to
6	hold everybody for three minutes.
7	WILHELMINA FUNDERBURKE: Pardon me.
8	SUPERVISOR GILLEN: I try to hold everybody
9	to three minutes, ma'am.
10	WILHELMINA FUNDERBURKE: But you didn't do
11	it before.
12	I am talking about just what happened
13	tonight.
14	I am sitting right here.
15	The young lady said to you she said I will
16	be finished up in a minute.
17	SUPERVISOR GILLEN: And, I let her.
18	WILHELMINA FUNDERBURKE: You didn't
19	interrupt him one time.
20	SUPERVISOR GILLEN: Thank you, Ms.
21	Funderburke.
22	WILHELMINA FUNDERBURKE: Thank you.
23	SUPERVISOR GILLEN: Do you have anything to
24	say about the budget?
25	WILHELMINA FUNDERBURKE: I am not going to

1	get up until I am finished.
2	I am telling you right, now and don't
3	interrupt me, okay.
4	I want to be treated like the gentleman who
5	just left here, thank you.
6	Okay, the question that I like to ask is in
7	Newsday, it was reported that 3.8 million dollars
8	that is why you didn't pass the budget the last
9	time, you had a meeting, I wasn't here.
10	Um, the Board did not know that the 3.8
11	million dollars had not been approved that the
12	Town was supposed to receive, has it been approved
13	that the Town is going to receive the 3.8 million
14	dollars?
15	SUPERVISOR GILLEN: It is still in
16	question.
17	SENIOR COUNCILWOMAN GOOSBY: According to,
18	I can tell you this, the reason we found out,
19	first of all that we weren't, was through
20	Assemblyman Ed Ra.
21	If he didn't tell us, we wouldn't have know
22	it, that was the day we were supposed to pass the
23	budget, that is why we didn't.
24	The information came into the Supervisor on
25	the $29^{th}$ and the $30^{th}$ .

1	She didn't explain it to us at all.
2	She didn't tell us that at all.
3	We didn't know that, so, when we found out
4	about it, I was very upset about it because I knew $^{ m Page} 28$
5	the money was coming to the County but I didn't
6	know how it was coming and how it was done and
7	when we got a letter from the County Comptroller
8	that there was no mechanism for us to receive that
9	money 3.8 million dollars would have created a
10	big hole in our budget.
11	So, finally, um, this was a Wednesday or
12	Thursday, there was an article in Newsday put an
13	article, whatever, they say not what we say, they
14	always say it differently.
15	Um, she said that she was trying to find a
16	way to work with NIFA and others to make sure that
17	we got that money and I think she is going to have
18	a meeting on November $12^{ m th}$ and she is going to
19	assure that we get the 3.8 million dollars that
20	would have left a big hole in our budget.
21	She knew it and she had gotten a letter,
22	but we didn't.
23	So, we should be getting that money through
24	NIFA.
25	WILHELMINA FUNDERBURKE: The question

that I am asking is, are you sure you are going to receive this money?

I haven't heard anyone yet, say, yes, we are certain we are going to get this money because from reading the paper, it says it was explained that, you know, the Board has said if they don't receive this money, it is going to be a big deficit if this budget is passed, am I correct or am I wrong?

COUNCILMAN BLAKEMAN Yes.

No, actually, we have received assurances from the County Executive and the Presiding

Officer of the Legislature that the 3.8 million will be there.

And, we also consulted with our financial people and we feel that in the unlikely event it is not there, that we would be able to develop a contingency plan to make up for that.

SENIOR COUNCILWOMAN GOOSBY: Okay and I can tell you, now, we had a meeting with our attorneys which we are entitled to do, that is part of the regulations of the State of New York and we received a letter that we were in violation that we should go to school, that they should take us back to school to learn how we are supposed

1	to function, that is because the person that wrote
2	it didn't know how we function.
3	We function we can have a private
4	meeting as long as we have attorneys and we are $^{\mathrm{Page} 30}$
5	seeking information, which we did.
6	So, somebody had that wrong, too, a lot of
7	wrong things going around, here.
8	WILHELMINA FUNDERBURKE: Well, I have been
9	coming to quite a few meetings and just about
10	every time I come, the Board is complaining that
11	something that the Supervisor has done or plans to
12	do have not been discussed with the Board.
13	This I don't understand how in the World a
14	Supervisor thinks she has more power than the
15	Board Members.
16	I don't understand that.
17	Everybody is supposed to be discussing
18	things with the Board.
19	And, then, you make a decision and the
20	Board is not supposed to come to the meeting and
21	to the public and say, oh, we can't vote on this
22	today because we are just hearing about it.
23	That is definitely not
24	SUPERVISOR GILLEN: You know what, ma'am, I
25	just got an amendment to the budget today

that they didn't discuss with me, that they had a Press Conference at 11:00 o'clock and at their Press Conference, I asked for a copy of it and I  $\frac{}{\text{Page} \mid 31}$ 

So, they are doing exactly what you are saying.

WILHELMINA FUNDERBURKE: They are doing exactly what you have been doing all year, that is what they are doing, because I come to these meetings a lot.

I missed quite a few because I had surgery.

I come to these meetings quite a lot, not only that, I read Newsday every day, which is not fair any way, but, I know from coming to these meetings every month, every time I come, you got to postpone something and come back because the Board - you did not inform the Board before this issue came up, so, you know, what you are saying, now, is something that you have been doing all along.

You know, it should stop because it is a waste of our time too, because if everything is done right when you come to the meetings, you can vote on what you are going to vote on if the Board know and then we don't have to come back.

1	(Whereupon, the three-minute bell rang.
2	After, the following ensued.)
3	WILHELMINA FUNDERBURKE: I am not finished,
4	so, I am not about to get up, I will tell you $Page \mid 32$
5	that.
6	The next thing I want to say to you is that
7	I have been reading a lot this has nothing to
8	do with the budget.
9	I have been reading a lot in the paper
10	about you selling property in Roosevelt
11	SUPERVISOR GILLEN: Okay, today we are only
12	talking about the budget.
13	WILHELMINA FUNDERBURKE: I don't care.
14	SUPERVISOR GILLEN: We are only talking
15	about the budget, today.
16	We are not selling property in Roosevelt.
17	We are only talking about the budget,
18	today.
19	It is a Special Meeting.
20	WILHELMINA FUNDERBURKE: You need to speak
21	to the people in Roosevelt.
22	SUPERVISOR GILLEN: There is nothing on the
23	market in Roosevelt right, now, except privately-
24	owned property.
25	The Town is not selling any property

1	at the moment.
2	Thank you.
3	SENIOR COUNCILWOMAN GOOSBY: At the moment.
4	WILHELMINA FUNDERBURKE: The Western Beef $^{ extsf{Page} 33}$
5	parking lot is not publicly owned, that is owned
6	by the Town, okay.
7	SUPERVISOR GILLEN: Indeed it is.
8	Okay, we don't have is there anybody
9	else that would like to be heard on the budget?
10	Is there anybody else that would like to be
11	heard on the budget?
12	WILHELMINA FUNDERBURKE: One thing for
13	sure, they can't get up until I get up and I don't
14	think anybody is going to pick me up.
15	SUPERVISOR GILLEN: Is there anybody else
16	that would like to be heard on the budget?
17	WILHELMINA FUNDERBURKE: I will get up this
18	time.
19	COUNCILMAN DUNNE: Ma'am, I appreciate
20	everything that you said.
21	Thank you for coming. Thank you very much
22	for being, here.
23	SUPERVISOR GILLEN: No one else on the
24	Budget?
25	(Whereupon, no response was heard. After,

1	the following ensued.)
2	SUPERVISOR GILLEN: Okay, may I have a
3	Motion on the budget as amended.
4	$\stackrel{ ext{Page} \mid 34}{ ext{COUNCILMAN BLAKEMAN:}}$ I move that we pass
5	the budget as amended.
6	SENIOR COUNCILWOMAN GOOSBY: I second the
7	Motion.
8	SUPERVISOR GILLEN: Madam Clerk, please,
9	call the roll.
10	CLERK CABANA: Supervisor Gillen?
11	SUPERVISOR GILLEN: Tow years in office,
12	two years of tax cuts for residents, I am proud to
13	present a budget proposal that cuts taxes for
14	residents and I am delighted that the Town Council
15	has decided to follow my lead on that.
16	I take complete credit for this tax cut
17	because I am quite confident that residents would
18	not be getting their taxes cut since the went up
19	99.3 million dollars until I arrived.
20	I think holding a vote on the budget on the
21	night before an election is clearly political
22	theater after delaying it twice.
23	Residents can see through it.
24	Never before to my knowledge has it taken
25	five separate meetings of the Town Board

1	to complete the Annual Budget Process.
2	I vote ay on the budget, something that we
3	should have done weeks ago. Thank you.
4	CLERK CABANA: Councilman Blakeman? Page   35
5	COUNCILMAN BLAKEMAN: Yes, I am very proud
6	to vote aye
7	SENIOR COUNCILWOMAN GOOSBY: She is
8	leaving. What do we tell her
9	(Whereupon, Supervisor Gillen left the
10	meeting room. After, the following ensued.)
11	COUNCILMAN BLAKEMAN: We cut taxes by
12	eight percent over the past two years, aye.
13	CLERK CABANA: Councilman D'Esposito?
14	COUNCILMAN D'ESPOSITO: Speaking of
15	political theater; first and foremost, I like to
16	comment on the two years in office that the
17	Supervisor was just speaking of and point out that

6	important because our people really need to have
7	as much saving as they could since what happened
8	to them before.
9	I am very sorry that the Supervisor feels
10	she cut taxes, because we did it the first time.
11	We did not. She wanted to raise taxes.
12	We cut the taxes and this time, we have cut
13	them even further.
14	And, it is not going to hurt our people.
15	It is not theater. We did not know that we
16	were going to get a were not getting the $3.8$
17	million dollars from the AIM Program that we
18	should have gotten.
19	The Governor changed it this year.
20	The AIM Program money always came directly
21	to the Town.
22	And, some of you may not know we use that
23	money for roads and we also use it to help the
24	people who are disadvantaged at our Anchor

2	because you know if we had not gotten that 3.8, it
3	probably would have been a 12 percent tax hike and
4	She would have been right in it and we would have
5	gotten caught in it because what she was trying to
6	do it and go ahead and pass the budget and not
7	know we would be 3.8 million dollars short, that
8	is what bothered me.

2	Herald and Channel 12.
3	I have cut my subscription. I stopped my
4	subscription to Newsday. Page   39
5	They are not free to all of us, all of us.
6	You never see anything about my District,
7	that is going on, that the children do, that our
8	people do.
9	We are part of this community.
10	We are part of Nassau County and they act
11	as if we aren't.
12	It has been on one person this whole time.
13	I never have seen that in my career a
14	newspaper or Channel 12 that has done what they
15	have done.
16	They are talking about the theatrics, I
17	don't know who is paying them or who is doing
18	whatever they are doing but it is wrong.
19	And, this is the United States of America.

21	that is gone, now, so, thank you all very much.
