3	Hearings for the Assessment Roll for the Greater
4	Atlantic Beach Water Reclamation District for the $$^{\mbox{\sc Page} 3}$$
5	fiscal year commencing January 1, 2021 and the
6	preliminary budget of the Town of Hempstead for
7	the fiscal year commencing January 1, 2021.
8	Madam Clerk, will you, please, call the
9	roll.
10	CLERK MURRAY: Supervisor Clavin?
11	SUPERVISOR CLAVIN: Here.
12	CLERK MURRAY: Councilman Blakeman?
13	COUNCILMAN BLAKEMAN: Here.
14	CLERK MURRAY: Councilman Carini?
15	COUNCILMAN CARINI: Here.
16	CLERK MURRAY: Councilman D'Esposito?
17	COUNCILMAN D'ESPOSITO: I am here.
18	CLERK MURRAY: Councilman Dunne?

21	October 2 nd .
22	The Assessment Roll was reviewed by the
23	Town Comptroller and filed in the Town Clerk's
24	Office on October 7^{th} pursuant to the New York Town
25	Law Section 239, the Town Board has the authority

1	to consider and accept the amended Assessment

14	We have a couple of people that like to be
15	heard on this, I will start with Felix Procacci.
16	Name and address for the record, please.
17	FELIX PROCACCI: Felix Procacci, Franklin
18	Square.
19	SUPERVISOR CLAVIN: Do you live on a
20	street, sir?
21	What street is that?
22	FELIX PROCACCI: On Barnes Street.
23	SUPERVISOR CLAVIN: Thank you.
24	FELIX PROCACCI: Has the Town completed its
25	2019 audit, yet?

1	COMPTROLLER MASTROMARINO: No, because of
2	the COVID virus and lack of ability to get into
3	the Town and the lack of the auditors, they had to
4	shut down their own office. $Page \mid 10$
5	They are in the process of starting the
6	audit and it is not complete.
7	FELIX PROCACCI: How many reserves are used
8	in the 2021 budget?
9	COMPTROLLER MASTROMARINO: We are proposing
10	to use, approximately, nineteen million.
11	FELIX PROCACCI: Nineteen million in
12	reserves. The budget indicated that some of the
13	Departments are being cut in the 2021 budget.
14	Um, I went through it thoroughly. There is
15	quite a few being cut than a lot more being
16	increased.
17	Um, which departments are being cut, in
18	particular, you know, the most?
19	COMPTROLLER MATROMARINO: It is kind of
20	self-explanatory, if you go through each budget
21	line by line, page by page, you will see the 2020
22	budget and next to it you will see the 2021
23	budget.
24	FELIX PROCACCI: I did go through that.
25	The reason why I asked the question is

1	because overall you say you are using nineteen in
2	reserves, I went through the entire budget, I got
3	sixteen million over, you know, over from last
4	Page 11
5	Since you are freezing taxes, the sixteen
6	million ahs to come from somewhere.
7	You say you need nineteen. You are
8	probably right, um, also yeah
9	COMPTROLLER MASTROMARINO: It is nineteen.
10	FELIX PROCACCI: Nineteen, okay, I believe
11	you. I am not I don't have as much data as
12	you did.
13	Um, has the Town borrowed the forty million
14	dollars to repair the road in the Town of
15	Hempstead?
16	Back on March $31^{\rm st}$, we passed a Resolution
17	to borrow the money.
18	In May, Newsday wrote a story that we were
19	going to do a stimulus of forty million dollars to
20	fix the roads in the Town of Hempstead.
21	I went on the municipal bond websites and I
22	couldn't find any issues at all for 2020.
23	COMPTROLLER MASTROMARINO: We haven't yet
24	actually puled the trigger on that.
25	We anticipate before the end of the year

1	Possibly November or early December to go out to
2	the market.
3	FELIX PROCACCI: Yeah, it is better to do
4	the roadway when it is warmer. Page \mid 12
5	We have to use more expensive asphalt it
6	costs more to do it in the cold weather if you are
7	going to try that and you're limited because of
8	the temperature.
9	So, I thought we were going to do the
10	forty-million-dollar stimulus plan last May and we
11	are not doing that.
12	Um, also, the postage, I see that the
13	postage budget has exceeded this year's budget.
14	In May you already exceeded the entire
15	year's budget for postage and the next year you
16	are looking to do a six hundred and fifty-
17	thousand-dollar increase.
18	Why are you increasing postage six hundred
19	and fifty thousand dollars for next year?
20	I remember as Candidate Clavin said he was
21	against mailings and minimal mailing and, now, we
22	are increasing it like fifty percent, close to
23	fifty percent.
24	COMPTROLLER MASTROMARINO: A lot of the
25	mailings this year were because of the COVID

1	Virus.
2	FELIX PROCACCI: I understand. Now, you
3	are budgeting for next year an additional six
4	hundred and fifty next year.
5	Are you planning on another virus?
6	SUPERVISOR CLAVIN: Mr. Procacci, in all
7	due respect, um, I don't think you are a medical
8	expert and you know what, we don't know where we
9	are going to be next year.
10	So, please, he is not budgeting for another
11	virus.
12	Please, don't frame it that way. It is
13	inappropriate.
14	FELIX PROCACCI: Well, it is put that way
15	to me that the reason why you spent money on
16	mailings this year is because of was because
17	of COVID and quite frankly, most of the mailings,
18	especially the early ones were inaccurate.
19	They didn't have social distancing and
20	didn't have mass usage.
21	So, they really you misled people until
22	the CDC came along and gave a different point of
23	view.
24	Thank you so much.
25	SUPERVISOR CLAVIN: Thank you and thank you

1	for recognizing the tax freeze.
