WHEREAS, J&M Inspection Service offers to provide inspection and lamp replacement on elevated and ground water storage tanks in East Meadow (2), Levittown (2), Bowling Green (1), Lido-Point Lookout (2), Roosevelt Field (1) and Uniondale (1) Water Districts; and

WHEREAS, J&M Inspection Service in a proposal dated January 20, 2021 has offered to inspect the interior of seven elevated and two ground water storage tanks on a semi-annual basis and to make payment of \$3,900.00 semi-annually for a yearly total of \$7,800.00 to cover the period January 1, 2021 through December 31, 2021; and
