3	Madam Clerk, please, call the roll.
4	DEPUTY CLERK POKALSKY: Supervisor Clavin?
5	SUPERVISOR CLAVIN: I am here.
6	DEPUTY CLERK POKALSKY: Councilman Carini?
7	COUNCILMAN CARINI: Here.

25	SUPERVISOR CLAVIN: All right, Madam Clerk,

1	please call the first Public Hearing.
2	DEPUTY SUPERVISOR POKALSKY: Petition of the
3	Commissioner of Buildings to demolish and remove a two-
4	story wood frame, one-family dwelling with a detached
5	garage and remove all litter and debris from property -
6	East side of East Avenue, 349 feet South of Meyer Avenue,
7	Section 40, Block 3 and Lots 107-108 (aka 37 East Avenue,
8	near Lawrence - Department of Buildings.
9	SUPERVISOR CLAVIN: Okay. Any member, any
10	Board Member have any comments?
11	(Whereupon, no comments were heard. After,
12	the following ensued.)
13	SUPERVISOR CLAVIN: If not Commissioner Leo,
14	want to identify yourself and just give a heads-up on what
15	you're doing?
16	Hold on, hold on. Check his mic. There you
17	go.
18	DEPUTY COMMISSIONER LEO: Morning,
19	supervisor, Members of Board, Daniel Leo, Deputy
20	Commissioner, Building Department.
21	SUPERVISOR CLAVIN: Why don't you just tell
22	us what you're doing?
23	DEPUTY COMMISSIONER LEO: This morning we are
24	talking about 37 East Avenue in Lawrence.
25	We had gone for a demolition on this

1 property. 2 The homeowner, since, has filed an 3 application to remedy the situation. We do have the engineer here this morning 4 5 who I'd like to have elaborate a little bit further on 6 this. 7 The plans that were submitted, which I also 8 gave everybody on the Board a copy of the photos, the floor 9 plans that were submitted, and the initial survey damage 10 that was on this property. 11 The plans that were submitted do not address the issues that we observed in the field. 12 13 I like to give the applicant a week or two to correct the plans to reflect the true nature of the 14 15 repair. If not, I recommend we go through with a 16 17 demolition. SUPERVISOR CLAVIN: Okay. I have a couple 18 19 of people asked to speak and hold off. 20 And, of course, when you speak, go to the 21 back podium, that'd be awesome. 22 We'll start with Mrs. Gogle. 23 Right back there, Chris, Chris Carini, 24 wave your hands. 25 If you give your name and Good morning.

address for the record. Thank you. 1 2 LORRAINE GOGLE: Good morning, all. Lorraine Gogle. Seven West Avenue, Lawrence of Meadowmere 3 Park. 4 5 I am here to say that I believe the house 6 should be demo-ed. 7 I'm in the community 39-plus years, and I 8 have just watched that house deteriorate literally by the 9 minute. It's an unsafe structure. 10 11 And to fix it up as the new owner wishes, I 12 can't imagine. 13 I just rebuilt my house after Sandy, and 14 fixing my house prior to it was just not an option. 15 It had to be completely rebuilt. So, that is my statement that I believe it 16 17 should be demoed. 18 I do have a letter that I'd like to submit 19 from the neighbor who lives next door. 20 She had to go to work today. And, who would I give that to? 21 22 SUPERVISOR CLAVIN: You're going to give 23 that to the Town Clerk, who is going to have somebody go back there and we will make it part of the public record. 24 25 Could you just identify who the letter is

from? 1 2 LORRAINE GOGEL: Yes, Mrs. Carolyn Benino. 3 She's at - - oh, gosh, I don't know what - - she's right next door. The house directly next door. 4 5 I don't know what her address is. 6 SUPERVISOR CLAVIN: Okay, we'll make it apart 7 of the record, okay. 8 LORRAINE GOGEL: Okay, thank you so much. 9 SUPERVISOR CLAVIN: No problem. Thank you. 10 Next, I have Ruth Samuelson. There you go, 11 Ruth. Right back there. 12 Good Morning, just give your name and address 13 for the record, thanks. 14 RUTH SAMUELSON: My name is Ruth Samuelson. 15 I live at 37 West Avenue, Lawrence, Meadowmere Park. I have watched this house for over 50 years, 16 17 slowly deteriorate. 18 Nothing is ever done with it. 19 About forty or fifty years ago, the original 20 owner raised the house and the first floor fell in. 21 And, anything that fell out of that first 22 floor remained under the house, the refrigerator, the 23 stove. 24 The foundation is a mess. 25 The entire house is a mess.

I worry about children playing. 1 2 Children go - - They go anywhere. So, it would be very dangerous for them to be 3 around that house. 4 5 That house needs to be pulled down for the 6 benefit of everyone in Meadowmere Park. 7 Thank you. SUPERVISOR CLAVIN: Thank you very much. 8 9 Next, I have Diane Kircher. 10 (Whereupon, "I am not speaking" was heard 11 called out from the audience. After, the following 12 ensued.) 13 I have Loni Locascio. Next, If you would state your name an address for the record. 14 Thank you. 15 My name is Loni Locascio. I live at 2 West Avenue, Meadowmere Park. 16 17 I've lived in this neighborhood for twenty-18 one years. 19 And, the house has been abandoned all those 20 twenty-one years. 21 There are animals living in the rafters of the 22 house. 23 And being that there's no bulkhead, every 24 time the tide comes up, the foundation is under saltwater. 25 I mean, it was hit by Hurricane Sandy and

1	nothing has been done.
2	The house needs to be demolished. Thank you.
3	SUPERVISOR CLAVIN: I don't have any other
4	slips.
5	Does anybody who did not sign in wish to be
6	heard on Item number 1?
7	(Whereupon, no comments were heard. After,
8	the following ensued.)
9	Deputy, if you give us what your thoughts are
10	on the proposal.
11	DEPUTY COMMISSIONER LEO: My thoughts on this
12	are, if the bulkhead is not addressed, if he doesn't reach
13	out to Conservation & Waterways and stop the erosion on
14	this property, along with submitting a set of plans showing
15	true remedies to the problems that were presented, I feel
16	we should move forward with the demolition.
17	SUPERVISOR CLAVIN: My question or point,
18	haven't we made motions to accept it and then given an
19	opportunity for them to rectify while still accepting the
20	demolition, is that correct?
21	DEPUTY COMMISSIONER LEO: That is correct.
22	SUPERVISOR CLAVIN: Okay, I think that would
23	be fair enough to be consistent on that.
24	Does anybody else wish to be heard on this?
25	(Whereupon, no comments were heard. After,

7	When we first moved there, it was a rented
8	home.
9	I never knew who the owner was.
10	And then a family bought it. And it's a
11	product of a tragedy of 9/11.
12	That's all I'll say. Very sad.
13	I did enjoy the people who did live there, but
14	then they left the house, abandoned it, squatters moved in.
15	Teenagers break into the property all the time.
16	We're right next door. I've called the police, you know,
17	every time I see anybody on the property, I call the Nassau
18	County Police to try to make a record of it.
19	So, the foundation is cracked.
20	There are animals living in it, a great
21	distraction for my two dogs, let me tell you.
22	It's been torture, especially the squatters that
23	were there.
24	I can't even get that part of my life back.
25	It was so stressful.

1	It needs to be torn down.
2	It's a wonderful, wonderful block.
3	If I had a nickel for every time somebody
4	knocked on my door asking to buy that home, I'm telling
5	you.
6	But for some reason, I don't know the mechanics
7	behind the mortgage or the back taxes or anything, it needs
8	to be taken down, a new home put in.
9	Thank you.
10	SUPERVISOR CLAVIN: Thank you very much.

1	construct a one-story 26' x 46' convenience store, install
2	fuel dispensing pumps, construct overhead canopy over three
3	(3) pump islands, other associated site improvements
4	including grading, landscaping, paving, parking, curbing
5	and lighting and to modify and rescind existing restrictive
6	covenants in order to modify a previous approved site plan
7	- near MALVERNE - northwest corner of Hempstead Avenue &
8	Morris Avenue.
9	SUPERVISOR CLAVIN: Counsel, Good Morning,
10	If you would identify yourself for the record.
11	ATTORNEY O'BRIEN: Yes, Good Morning,
12	Supervisor Clavin, Deputy Supervisor Goosby, Honorable
13	Members of the Board.
14	Kevin O'Brien from O'Brien Law, P.C., 462
15	Sagamore Avenue, East Williston, New York, here, this
16	morning in connection with this application on behalf of
17	the applicant.
18	And, I noticed my Architect, Mr. Michael
19	Rubenstein, just arrived and he's joining me with the
20	presentation on this application, if there are any
21	questions of a technical nature.
22	This is an application involving the premises
23	at 471 Hempstead Avenue in Malverne, variances from the
24	provision of the "GSS" zoning ordinance.
25	The property, itself, is located at 471

Hempstead Avenue, and it's interesting the way it's 1 2 situated over there, the way Hempstead Avenue is, it's not exactly on the corner of Atlas. 3 So there's kind of two corners that are kind of 4 5 close by. One is Morris, one is Atlas, but they're not 6 7 necessarily really on the corner, itself. 8 And the way the property is situated, you got 9 Hempstead Avenue, and it's one roadway that heads South, 10 but then it splits into two roadways that you've got Ocean 11 and you have Hempstead. 12 We are in close proximity to the Village of 13 Malverne, but we're not actually in the Village. 14 I'm not one hundred percent sure on the 15 overheads, but I was able to grab, if I could just submit at the last minute, one copy of an elevation or drawing to 16 17 see what the building itself is going to look like. 18 So, if I could just submit that. 19 SUPERVISOR CLAVIN: Grab somebody from the 20 Clerk's office, so he could submit that. 21 ATTORNEY O'BRIEN: Okay, thank you. 22 Historically, it is interesting, on the way 23 driving over here this morning, I just thought I said, Wow, I said, this place has been operating as a gasoline service 24 25 station since 1927, saying, damn, what the cars must have

1	been like in 1927 compared to what we have today.
2	So, it's been operating almost for 100 years.
3	And, what is it that actually, the
4	property is a little over 10,000 square feet.
5	It was built and operated as a two-bay repair-
6	oriented service station, pump islands and underground
7	gasoline storage tanks.
8	And throughout the years, obviously over close
9	to 100 years, there have been various applications and the
10	like that have come some have come before this Board in
11	other mostly just replacing the underground gasoline
12	storage tanks.
13	So, we did $-$ - or the applicants or the
14	property owner had come before the Board.
15	The property is actually located in the "GSS"
16	Zoning District, which is the correct zoning district for
17	gasoline service stations within the Town of Hempstead.
18	And it did have its underground gasoline
19	storage tanks replaced.
20	There are two, double-wall fiberglass
21	underground gasoline storage tanks.
22	All permitted, all meeting or exceeding the
23	County, State and Federal regulations.
24	As the Board is probably aware, at this point,
25	that the impetus for that is that there's a requirement by

1	the County that all single wall tanks had to be replaced
2	within a certain period of time and that was done.
3	So what brings us to the Board today is (A) when
4	that was done, the application, as most applications, if
5	they are approved by the Board, are approved, substitute to
6	a specific site plan and specific improvements on that site
7	plan and we're seeking to modify them.
8	And why is that? Sort of twofold, one is the
9	way the cars come in.
10	There are three pump islands and they're sort of
11	catty cornered.
12	The purpose for that is to really kind of get
13	the cars off the roadway and queue on site as opposed to
14	you don't want to have cars queuing on the roadway,
15	particularly on that roadway over there.
16	I mean, while the Nassau County Planning
17	Commission recommended local determination, it is the type
18	of roadway that you want to keep the cars off the roadway.
19	You don't want any sort of queuing onto the
20	roadway.
21	So they configured the pump islands in such a
22	manner so as to be able to do that.
23	In so doing, though, the building is really it
24	makes it very difficult for cars to egress or to make a
25	fueling vehicle be able to get in and out of there in that

1	way.
2	So the nature of the application today is to
3	modify the previously approved site plant, completely
4	demolish the building that was there using the identical
5	size building, which is basically just shy of twelve
6	hundred square feet, push that back about between ten and
7	fifteen feet, same size, but this way it would enable for
8	much better on site circulation, you know, for both
9	vehicles and for any deliveries that are proposed for the
10	location.
11	The building that currently exists and
12	construction, quite frankly, has stopped.
13	All the work that was done was done pursuant to
14	permits, but when they came to this problem, they had to
15	apply for new permits.
16	So all construction is basically stopped at
17	this location, hasn't been operating but they're looking to
18	push the building back, as noted, operate it as a
19	convenience store.
20	We're mindful of the fact that the way the area
21	is, it's principally, at least this section, residentially-
22	oriented neighborhood.
23	So the style of the building we're trying to
24	keep residentially oriented.
25	It would not be a 24-hour operation.

1	I don't think that would work at this
2	particular location.
3	Your Commercial area is really a little bit
4	further down towards Malverne.
5	So we're trying to be mindful of that, design
6	it in such a manner, like I said, I was able to kind of
7	grab at the last minute an elevational drawing, which would
8	show that,
9	I'm sorry, I don't have a colored copy of that.
10	And then, obviously, all the other improvements
11	that would go along with the service station.
12	Right, now, it's unpaved because the tanks were
13	dug up.
14	So, of course, you'd be paving that.
15	There'd be landscaping throughout the site.
16	There's old fencing at the location, so all the
17	old fencing would be removed and replaced.
18	And that is really the nature of the proposed
19	and the pump islands they have, there would be a canopy
20	that would be over those pump islands.
21	The lighting would have to be designed in such a
22	manner that it just stays underneath the canopy.
23	The canopy fascia, other than maybe some signage,
24	would not have any lighting on the canopy fascia, itself.
25	So that's the nature of the types of improvements

1	that are being proposed.
2	And like I said, the nature of the relief is
3	because of the fact that the previously approved site plan,
4	I think believe, pursuant to maybe the "GSS," application,
5	where there were certain covenants and restrictions
6	associated with that application, would have to be modified
7	with, I'm certain, a new set of restrictive covenants
8	applicable to the Site Plan which is being presented to the
9	Board.
10	So, if there are any questions whether it be of
11	an operational nature, I can handle that.
12	Of a technical nature, I do have Michael
13	Rubenstein here with me today, and I'd be happy to answer
14	any questions that the Board might have or any interested
15	observers.
16	SUPERVISOR CLAVIN: Okay. I know we got a
17	couple of questions myself.
18	So, I'm just trying to put it all together.
19	ATTORNEY O'BRIEN: Absolutely.
20	So, this is on Hempstead Avenue.
21	If I'm going South, it's on my right hand side.
22	ATTORNEY O'BRIEN: Right hand side.
23	SUPERVISOR CLAVIN: And it's right after the
24	parkway, right?
25	ATTORNEY O'BRIEN: Yes, that's correct.

1	SUPERVISOR CLAVIN: It is the one with the tacky
2	looking bad fence on it, right? No, no, right?
3	ATTORNEY O'BRIEN: Say it again.
4	SUPERVISOR CLAVIN: It's got a bad-looking fence
5	surrounding the property, right?
6	ATTORNEY O'BRIEN: Yes.
7	SUPERVISOR CLAVIN: And somebody was parking
8	equipment on it until recently, am I right about that?
9	ATTORNEY O'BRIEN: I was there recently.
10	There was a backhoe on the site, I think.
11	SUPERVISOR CLAVIN: Were they allowed to have
12	the backhoe on the site?
13	ATTORNEY O'BRIEN: Well, while they were doing
14	construction

10	haven't maintained it really that well to get people pumped
11	up about it, right?
12	ATTORNEY O'BRIEN: Right.
13	SUPERVISOR CLAVIN: Okay, at least, we have
14	the admission.
15	So, now, you want to put a gas station there.
16	Okay, it's not going to be 24 hours, am I correct
17	about that?
18	ATTORNEY O'BRIEN: Correct.
19	SUPERVISOR CLAVIN: I don't have and you correct
20	me if I'm wrong, I do not have, with the exception of the
21	nice color photos I have, that you are not going to like, I
22	don't have any sort of, like, color visual that's showing
23	me any sort of green, any sort of layout.
24	I got a lot of black and white.
25	Do you have anything that's going to give me a

1 better sense that I could say to people, like, this is what 2 it's going to look like? Mr. Rubenstein, do you have a 3 ATTORNEY O'BRIEN: colored site plan to reflect the landscaping? 4 5 Apparently, I don't. 6 I certainly - -7 SUPERVISOR CLAVIN: Okay, so that's not going to 8 help me, because I'm going to tell you right now, all I can 9 do is picture in my mind driving and seeing this bad 10 looking chain link fence. 11 I can't get past it on my mind. 12 And, I know these residents are thinking the same 13 thing. 14 And, like a color kind of something I could show 15 the residents would help in the process of getting people on board. 16 17 Now, you say you don't want it 24 hours a day, 18 right? 19 ATTORNEY O'BRIEN: Correct. 20 SUPERVISOR CLAVIN: Okay. 21 Have you talked to all the neighbors in the area? 22 Because I think that if I'm correct again, it 23 abuts, like, one or two residential properties, am I right? 24 ATTORNEY O'BRIEN: That's correct. 25 SUPERVISOR CLAVIN: It does, Okay.

1	So have we talked to them?
2	Were they energetic about this?
3	Were they all pumped up about this or did they
4	have some reservations?
5	ATTORNEY O'BRIEN: They had some reservations.
6	I was there last week.
7	I did speak to one of the contiguous property
8	owners and he was concerned about the fencing, the buffer
9	landscaping that would be included over there.
10	And I indicated that, yes, we'd be putting brand
11	new fencing, buffer landscaping.
12	If they'd like to choose some of the fencing or
13	the type of landscaping, because there are a couple of
14	different varieties.
15	Some grow quicker than others, some like that,
16	some don't like that.
17	SUPERVISOR CLAVIN: Again, like I said, I just
18	know the property pretty well driving by there, it's just
19	tough without a real visual to take a look at this, knowing
20	what's there to make the leap.
21	How many pumps used to be there before they took
22	them out? Two?
23	ATTORNEY O'BRIEN: I think there were two large
24	pump islands.
25	SUPERVISOR CLAVIN: And how many are you going to

1	put there now?
2	ATTORNEY O'BRIEN: I think they're two larger.
3	There may have been two per island, so it might
4	have been a total of four. So they're going to be three.
5	SUPERVISOR CLAVIN: And it's going to be a
6	convenience store.
7	So you're getting rid of the bays
8	and doing all the construction, which everyone always is
9	excited about that.
10	But it's not going to be 24 hours a day.
11	How many hours is it going to be?
12	ATTORNEY O'BRIEN: 5:00 o'clock in the morning
13	to maybe about 11:00 o'clock or midnight.
14	SUPERVISOR CLAVIN: Okay, and, then what are we
15	going to sell in our convenience store?
16	ATTORNEY O'BRIEN: Usual prepackaged goods.
17	It's comparatively small, a twelve hundred
18	square foot convenience store.
19	So convenience stores of that size and nature
20	generally sell prepackaged goods, as well as, coffee and
21	the like.
22	SUPERVISOR CLAVIN: Okay, I got the elevation
23	with the mini-mart, I appreciate that.
24	Now, Mr. O'Brien, you're no stranger to the Town
25	of Hempstead.

1	You've done numerous presentations in front of
2	the Town of Hempstead.
3	I can tell you with all certainty he's going to
4	ask about things like the American flag, all right.
5	And, then I can tell you with all certainty she's
6	going to say, what about shrubs and greenery?
7	It's making it a little difficult without these
8	sort of visual aids to get people in a comfort zone with
9	this.
10	Because like I said, I know what it looks like,
11	now.
12	I got a presentation of a black and white,
13	you know, front elevation, which shows me nothing else of
14	how this property is going to look.
15	And like I said, I have listened to residents
16	when I go around and trust me when I say to you, this one,
17	I know I got the complaints about the machinery being on
18	there.
19	I know it's gone.
20	That's really nice.
21	I know I've gotten the complaints about the
22	fact that it hasn't been maintained and it's an eyesore
23	going into or driving through the community I get that.
24	I'm saying it's making it a little tough to
25	get a good visual of this, of how it's going to look like

with this drawing that you submitted. 1 2 That one's not going to get me where I need 3 to be. ATTORNEY O'BRIEN: Supervisor, I perfectly 4 5 Understood. I'm a little surprised myself. agree. 6 I thought because I've actually got two 7 architects on the job, I thought I had colored elevations 8 and the like. 9 I know there is a landscape plan. It's not colored. 10 11 I know there is a flagpole on the South side 12 It doesn't really jump out. of the site. 13 I'd like, at least, the opportunity to submit to the Board some colored site plans which would 14 15 more clearly depict where the landscaping is. 16 SUPERVISOR CLAVIN: And I appreciate that 17 because like I said, and the residents too, listen, they 18 have to get a visualization of what is really going to be 19 transformed, if it's going to be and they deserve it. 20 Like I said, they've dealt with the 21 property, they've dealt with what the condition has been 22 in. 23 They've dealt with the fact that, 24 unfortunately, some stuff was parked that it shouldn't have 25 been parked and it's not there anymore.

1	But I think they deserve a really good
2	analysis of what it could be transformed into to really
3	form an opinion. As do it. As do it.
4	ATTORNEY O'BRIEN: I agree, and I think
5	just with respect to defense, though, I think because it
6	was a construction site, I think we're required by Town Law
7	to have but I agree with everything Mr. Supervisor, I
8	agree with everything you said.
9	SUPERVISOR CLAVIN: Like I said, I get the
10	property.
11	If you want to bring up another expert and
12	then we'll go through some questions with the residents.
13	Did you want to bring up anybody else?
14	ATTORNEY O'BRIEN: No. Unless there are
15	any particular questions, I think we're fine.
16	I'd be happy to respond to the residents or
17	anyone else.
18	SUPERVISOR CLAVIN: All right. I know there
19	might be one or two questions we have going on from I know
20	Councilwoman Ryder's got something.
21	COUNCILWOMAN RYDER: Hi, good morning.
22	ATTORNEY O'BRIEN: Good Morning.
23	COUNCILWOMAN RYDER: So, I live about a mile
24	from I live in Lynbrook, however, I live on the
25	Malverne border, so, I am very familiar with this proposed

site. 1 I, also, have several family members that 2 live 3 in Malverne, who are extremely concerned about the 4 5 aesthetics of the project. 6 I am fully aware that it abuts several 7 residential properties. 8 And what we don't see, which is very 9 disappointing, is a clear color visual of what the 10 constructed building is going to look like, as well as, 11 color renderings of any type of landscaping, screening and 12 barriers to the residential properties. 13 That's a concern that I have and it's tough for me to vote on this without seeing that and to 14 15 adequately represent my constituents in the area right now. ATTORNEY O'BRIEN: Councilwoman, I don't 16 17 disagree with you. 18 The plans do reflect some of this, but 19 doesn't jump out at you. 20 And I would just request the opportunity to 21 be able to provide to the residents and to yourself and the 22 other Members of the Board, while I believe a lot of the 23 information is on the plans, like I said, it doesn't jump 24 out. 25 When you have the color depiction, you'll be

1	able to see where all the landscaping is, the type, the
2	nature, what the building would look better.
3	So I agree with what you're saying and I would
4	just request that opportunity to be able to provide that.
5	COUNCILWOMAN RYDER: To the layman's eyes, not
6	to an Engineer, it's very difficult.
7	ATTORNEY O'BRIEN: And you couldn't be more
8	correct.
9	COUNCILWOMAN RYDER: Thank you.
10	SUPERVISOR CLAVIN: Deputy Supervisor, did you
11	have something to say.
12	DEPUTY SUPERVISOR GOOSBY: I really think that
13	you should take everything back and bring it the way you
14	know it should be given, you know, we have something to
15	look at, and the residents would have something that they
16	can look at and approve, give some approval.
17	Because as it is now, I don't approve any of
18	it.
19	ATTORNEY O'BRIEN: Understood, Deputy
20	Supervisor.
21	SUPERVISOR CLAVIN: Mr. O'Brien, like I
22	said, it's your decision.
23	There are obviously a number of residents
24	that have come down.
25	ATTORNEY O'BRIEN: And, I certainly think

1	they'd want the opportunity to be heard.
2	SUPERVISOR CLAVIN: Yeah, absolutely.
3	They're here now, so why don't we
4	ATTORNEY O'BRIEN: Perhaps, if we could come
5	back at another time, that'd be great or however the Board
6	feels comfortable.
7	SUPERVISOR CLAVIN: Okay. So I'm going to go
8	through I got a number here that when residents come
9	in, just go to the back podium and speak in.
10	I apologize if I mull your name. Christopher
11	Cirami. Okay, it wasn't Carini.
12	So we were happy enough that we get enough
13	Carini up here. So this works out well.
14	CHRISTOPHER CIRAMI: My name is Chris
15	Cirami. I'm at 10 Atlas Avenue.
16	My property abuts directly to the gas
17	station.
18	I am Section 201, I think on the map.
19	SUPERVISOR CLAVIN: Got you.
20	CHRISTOPHER CIRAMI: I think like 70% of my
21	backyard is in the gas station.
22	First thing is hours of operation,
23	obviously I have two small kids, you know, 11:00 12:00
24	o'clock at night, if they're planning on selling beer,
25	which I don't think they answered that or any kind of

alcoholic beverages doesn't need to be open at that point. 1 2 I think 9:00 o'clock is more than sufficient. 3 Traffic almost dies down. 4 5 Anybody going at that point is going on to 6 the Parkwav. 7 People really aren't going out and getting 8 gas. 9 And I wanted to see where my property is, 10 how tall the fence is going to be. 11 If there's going to be a guardrail, God 12 forbid something happened. 13 As it is, my house has been hit - -Not my house, my property has been hit six times, drunk drivers 14 15 coming off the Southern State Parkway. One of them actually went through my fence, 16 17 through the existing gas station when it was there and 18 knocked the handles off the pumps. 19 Thank God he didn't hit the pump. 20 But I think traffic wise, too, how were they 21 planning on keeping cars from pulling out and trying to 22 head back towards the Southern State Parkway? 23 Is there any kind of barrier that can be put 24 down? 25 That intersection is a mess.

1	There are accidents all the time.
2	Cops are there all the time.
3	What else was I thinking? That's all I got.
4	I know my neighbors have a lot more in depth questions.
5	Thank you.
6	SUPERVISOR CLAVIN: Thank you for coming
7	down.
8	COUNCILWOMAN RYDER: It is a very tricky
9	intersection.
10	SUPERVISOR CLAVIN: Howard Frauenberger.
11	Morning. Your name and address for the record again.
12	HOWARD FRAUDENBERGER: Morning. My name is
13	Howard Frauenberger. I live at One Atlas Avenue, which is
14	directly across Atlas Avenue from Chris. His property
15	adjoins this.
16	I actually look towards the proposed gas
17	station.
18	I've had the distinction of living in
19	Malverne for 61 years and I've lived in three different
20	locations.
21	This particular location for the past 19, I
22	guess it is,
23	SUPERVISOR CLAVIN: Just a quick reference
24	point for me, so are you actually in the Incorporated
25	Village portion of it?

1	HOWARD FRAUENBERGER: I'm in the
2	unincorporated area,
3	SUPERVISOR CLAVIN: Okay.
4	HOWARD FRAUENBERGER: Which is a wonderful
5	thing because I don't pay Village tax. Saves me a lot of
6	money.
7	SUPERVISOR CLAVIN: Oh, boy.
8	HOWARD FRAUENBERGER: Let me start out by
9	thanking the Board for their concern about the proposed
10	property changes.
11	I just learned about this when I stopped on
12	my bike and read the Notice that had gone up on the fence.
13	We have not been contacted by the proposed
14	new owners or new operators.
15	And so we're totally oblivious to what the
16	plan was until we just saw it on the screen, which I think,
17	you know, is something that should be corrected.
18	This is pretty much a unique location.
19	As you pointed out, it's on a split,
20	essentially, between Ocean Avenue and Hempstead Avenue.
21	And there's a right turn arrow right at that
22	light at that split, and people coming South travel at a
23	pretty good speed unless it's rush hour and the light is
24	red.
25	And, so anybody trying to get out of that gas

1	station and head to the right or even head across to go to
2	the left is going to have a real problem, especially in
3	rush hour.
4	When the railroad gates are down on Ocean
5	Avenue, we often have gridlock, and it's jammed up all the
6	way back almost to the parkway with cars.
7	So you know the area, you know the traffic
8	problems.
9	As a minimum, I think that the community needs
10	to be involved in, as you pointed out, in seeing what the
11	plan really is.
12	But I really think the Town of the Nassau
13	County Traffic Bureau really needs to take a good hard look
14	at the traffic situation here because it is very dangerous.
15	People heading North towards the parkway when
16	they come out of the Village of Malverne, which is
17	notorious for its speeding tickets, usually if the light is
18	green and they're heading towards the parkway, they floor
19	it.
20	And often they're going 50, 60 miles an hour
21	heading North towards the parkway, un-ticketed by Nassau
22	County Police, because I haven't seen a Nassau cop give a
23	ticket there in 19 years.
24	But the point is, it's a real dangerous
25	situation for people.

1	If they want to go into the station and they're
2	heading North, they got to cross over southbound, two lanes
3	of southbound traffic, which presents its own problem.
4	So as a minimum, I think the blind curve
5	presents a really unique situation.
6	I'm glad you're aware of that basic area
7	because it is kind of unique.
8	And when it was an operating gas station, there
9	was a proposal to redo it and there were several
10	restrictive covenants that this Board chose to apply, if
11	you will, to do the situation.
12	SUPERVISOR CLAVIN: I appreciate it. I'm going
13	to ask you to stick around after because obviously we do
14	have some concerns.
15	You can see that.
16	And I think we've expressed to the attorneys
17	that maybe some of the residents don't feel like they've
18	been included.
19	So of course, we're going to ask counselor to
20	get your name and address to do a follow-up with you.
21	Mr. O'Brien is very, very good about that.
22	But like I said, we're still here right now,
23	so we're going to go through a number of other residents.
24	Rosalie Mastrarrigo, you don't want to go?
25	Okay. Did I do okay with the name?

1	ROSALIE MASTRARRIGO: Yes.
2	SUPERVISOR CLAVIN: Thanks. I appreciate it.
3	Okay, good. All right. I like that.
4	Joseph, did you want to go?
5	JOSEPH MASTRARRIGO: I wrote a speech.
6	SUPERVISOR CLAVIN: If you'd like to submit
7	it, we will take any submission and the Clerk's office will
8	make it part of the record.
9	JOSEPH MASTRARRIGO: It basically shows the
10	history.
11	SUPERVISOR CLAVIN: We will be delighted to
12	make that part of the record. Thank you very much.
13	How are you doing? If you just give me name
14	and address of the record.
15	JOSEPH MASTRARRIGO: Morning, Joseph
16	Mastrarrigo, directly across the street.
17	I've lived there for over 21 years.
18	And when you say that it's not a 24 hours
19	deal, 5:00 in the morning till 11:00 at night is 18 hours,
20	but to me that's 24.
21	I don't know if they're serving beer,
22	alcohol.
23	You have to understand something, I've lived
24	there. I had to put a cone in my driveway because the cars
25	that come out turn in my driveway and then they go back to

1 the parkways. So they've ruined the driveway, so I put a 2 3 cone there. I've been threatened when people come into 4 5 the driveway, if I'm putting the garbage out, making that 6 turn, I don't want to be threatened. 7 I lived there a long time, paying a lot of 8 taxes, not only that, fighting. 9 And then when they go to this station I'm 10 across the street, you could see they park their cars in 11 the front of my house. 12 They talk, they yell, they scream, they drink, 13 they fight. 14 I call the police a lot of times. 15 I don't want to do that. I'm fearful of my property and my life. 16 17 When you're fearful of your life and 18 property, that's a big problem. 19 Tear it down. 20 Put a Youth Hall there to something for our youth. Do something right for the Town. 21 22 Also, if, God forbid, the kids are on the 23 street, they fly up that block. 24 I'm always yelling at people, "slow down" and 25 they stop the car, "I'll put you in a hospital."

1	Okay, I don't argue.
2	But next thing is they don't care.
3	They drink.
4	They throw stuff on my property. Beer cans,
5	stuff from the place.
6	I don't like it.
7	What else?
8	Something important, how close is that to the
9	Southern State going West and East.
10	God forbid that place is held up. God forbid.
11	The police aren't going to get there in time.
12	They're going to hurt somebody, kill somebody,
13	and they hit right on the parkway.
14	You're going to find them?
15	You are not going to find these people.
16	That's scary.
17	Safety. What else? My bedroom is facing it,
18	it faces it.
19	If they put bright lights up, it's bad enough
20	I can't sleep, pull the shades down, room darkening shades.
21	It's annoying.
22	I can't keep my windows open in the summertime
23	if it's cool out because there's talking, yelling,
24	screaming, come on, come on. This isn't for our Town.
25	I am sorry. I appreciate what the attorney is

saying, but he doesn't live there and he doesn't have 1 2 children there. We live there. 3 4 Okay, what else? That's really about it, but 5 I think I've said enough to get the point across that I 6 don't want it there. 7 I don't think anybody wants it there. 8 They've driven through, like, when they can 9 make that turn to go down Hempstead Avenue. 10 (Whereupon, the three-minute bell rang. 11 After, the following ensued.) 12 SUPERVISOR CLAVIN: Well, we appreciate you 13 coming, and we appreciate your comments, as always. 14 I got a couple of more I want to go through 15 here. Rosie, didn't. Kevin, we've heard from. 16 17 Is Michael Rubenstein with you? 18 ATTORNEY O'BRIEN: Yes. 19 SUPERVISOR CLAVIN: Okay. I don't have any 20 other slips from any other residents that wish to be heard 21 that signed in. 22 Would you like to be heard, sir? Sure. Ιf 23 you can go to the back and give your name and address for the record. 24 Thank you. 25 FELIX PROCACCI: Felix Procacci, Franklin

1	square.
2	I think that it would be beneficial to the
3	residents that before he comes in for the next application
4	Hearing, that the Town lets them put their materials up on
5	the website so the residents can view exactly what the
6	applicant is proposing, so they don't have to come in and
7	then be surprised that there's a black and white drawing,
8	and not a color.
9	And I think it should be good, should be done
10	for all applicants in the future. Thank you.
11	SUPERVISOR CLAVIN: Okay. I don't have any
12	other slips from any other residents.
13	Mr. O'Brien, I do have a couple of concerns
14	and questions.
15	And, I think rightfully so, the residents
16	have pointed out.
17	Just kind of going through it, one thing that
18	I see from your site plan, I can see it on this map, okay,
19	but I don't see it on the site plan, when you're going down
20	Hempstead Avenue, before you go to the Malverne Speed trap,
21	there's a fork right there in the road.
22	ATTORNEY O'BRIEN: Correct.
23	SUPERVISOR CLAVIN: Okay. So if I'm on
24	Morris Avenue, you know, when I come out of your store,
25	you're going to tell people to go left and right, and if

you have them go left, you're going to turn them right into 1 2 an island. ATTORNEY O'BRIEN: Mr. Supervisor, if I can 3 4 perhaps I've got the radius map here. 5 SUPERVISOR CLAVIN: Okay. 6 ATTORNEY O'BRIEN: I'm just looking at the 7 site map, and I'm looking at my eyes, and like I said, I 8 kind of know the area. 9 ATTORNEY O'BRIEN: Okav. 10 SUPERVISOR CLAVIN: So zoom back in there, 11 whoever had that. That was nice. I like that. 12 Okay, let's go to that site map. 13 Zooming in there, see down in Morris Avenue? ATTORNEY O'BRIEN: 14 Yes. 15 SUPERVISOR CLAVIN: Okay. Are you going to have egress coming in from that roadway? 16 17 ATTORNEY O'BRIEN: What's interesting, it's 18 an interesting - - and, I met with that property owner 19 right next door. 20 I'm trying to remember the gentleman's name. 21 And if you look at the property, it's 22 interesting, we're not technically contiguous to Morris. 23 So, you see this little triangular piece of 24 property over there, which is basically lawn. 25 So there's no eqress.

1	SUPERVISOR CLAVIN: What are you going to
2	have, like, a fence and greenery there?
3	ATTORNEY O'BRIEN: Yeah. So there's greenery
4	over there, and there's a fence indicated that we're going
5	to replace that fence.
6	SUPERVISOR CLAVIN: You see where it says
7	"112" on your picture up there?
8	ATTORNEY O'BRIEN: Yes.
9	SUPERVISOR CLAVIN: Okay, again, so hard.
10	How many entrances, exits are you going to
11	have along the Hempstead Avenue, right, there?
12	How many?
13	ATTORNEY O'BRIEN: So there will be two.
14	There'll be one at the North side of the site, one towards
15	the South side of the site.
16	And, the way the roadway naturally is and the
17	way the site is designed, it's really meant to be a right
18	hand in and right hand out type of location.
19	SUPERVISOR CLAVIN: Is that what you're
20	limiting?
21	Are you proposing you're only going to do
22	right hand in and right hand out?
23	ATTORNEY O'BRIEN: We could certainly do
24	that, yes.
25	

1	right now, somebody's really accurate, when they said you
2	try and make a left hand turn, you're literally going to be
3	crossing like, six lanes of traffic to try and get a left
4	hand turn.
5	That would be like, not good.
6	ATTORNEY O'BRIEN: And you're right.
7	You're absolutely correct. So it is designed
8	in that manner, but we could certainly specify.
9	SUPERVISOR CLAVIN: Okay, now, I also got
10	I'm looking at the subject property and I see you have like
11	the dumpster in the back up against the Rugo's fence.
12	ATTORNEY O'BRIEN: Right.
13	SUPERVISOR CLAVIN: Okay. Well, let me ask
14	you, when would that garbage be picked up?
15	Are you going to say to these people, it's
16	only been picked up between 7:00 A.M. and 5:00 P.M. or
17	something like that?
18	ATTORNEY O'BRIEN: Yeah, typically it's a
19	private carter.
20	And, quite frankly, it's interesting, these
21	locations do have dumpsters, but they don't generate the
22	kind of trash that the former repair-oriented service
23	stations.
24	SUPERVISOR CLAVIN: I'm not saying it
25	wouldn't, but I'm just saying that if I'm going to get

1	visited by a garbage truck, what time are you thinking
2	that's going to come in?
3	Just Residents like to come in and say, "I
4	live next to a gas station. What time are you delivering
5	gas?"
6	Let's be realistic about it.
7	ATTORNEY O'BRIEN: Yeah, so, we could design
8	that in such a manner that it wouldn't be in the late
9	evening hours or earlier than whenever the Town picks up
10	garbage.
11	We could certainly
12	SUPERVISOR CLAVIN: Because then it says back
13	there, "grass area," right.
14	Your plan says, "grass area," right there.
15	And then I see the boundary. So it's like, are
16	we going to put up a fence with greenery to make a buffer
17	to alleviate that noise?
18	I just see grass there.
19	What do you think?
20	ATTORNEY O'BRIEN: No, we'd certainly
21	personally, I prefer a Leyland Cypress.
22	I think it's a hearty disease resistant type.
23	A lot of people use Arborvitaes.
24	I like to actually mix them with other
25	varieties of trees, such as, like Western Red Cedars that

1	fill in.
2	Some people like White Pines because they'll
3	grow to 20, 30ft, though I've had other people complain
4	that they're too high and then you have needles.
5	So we'd certainly be willing to even work with,
6	you know, residents if there's a particular variety that
7	they would like.
8	I'm all for that, but absolutely you need an
9	Evergreen, and I believe there are proposed Evergreens over
10	there.
11	But certainly the way we need something to
12	be colored, show the variety of the landscaping, the color
13	of the landscaping and the like.
14	SUPERVISOR CLAVIN: I got you.
15	And then your other expert that's here today,
16	what did he check into?
17	ATTORNEY O'BRIEN: I don't think he's an
18	expert.
19	SUPERVISOR CLAVIN: Did you have any sort of
20	traffic study done to tell us what you found there?
21	ATTORNEY O'BRIEN: I think we've been in
22	communication with Nassau County and the like.
23	And, I think that once again, that concept is
24	the right hand turn in, the right hand turn out.
25	And that I think is the design that even the

1	County has been looking for.
2	SUPERVISOR CLAVIN: Okay, like I said, because I
3	have some concerns and I think rightfully so, someone
4	brought up also the backup, when the train comes through,
5	it backs up.
6	ATTORNEY O'BRIEN: Understood. And there are
7	certainly things, quite frankly, that we can do and there
8	are certain things that we can't do.
9	I mean correctly, So, you do have maybe the train
10	backing up.
11	So we can guide things.
12	We can limit things.
13	We can restrict things, but we certainly can't
14	eliminate a grade cross.
15	ATTORNEY O'BRIEN: No, no, no, I get you, but I'm
16	saying I just want to know if you're kind of taking into
17	account you're putting a gas station in with cars are going
18	to pump over that.
19	The cars are coming off the Southern State
20	going South and all of sudden I'm sitting on the train
21	tracks.
22	And as a practical matter, if something is
23	blocked then just people being what they are.
24	It's got to be easy and simple.
25	If it's difficult or if it's blocked because of

1 people queuing, they're not going to go. 2 SUPERVISOR CLAVIN: Obviously, you heard from a couple of the residents that they didn't think they were 3 4 really informed on it. 5 A couple of - - the nice gentlemen who said it 6 was like jogging by ride his bike. 7 ATTORNEY O'BRIEN: Yeah, I like to, if the 8 gentleman sticks around, I'd certainly like to meet with 9 him because we had radius maps and everything prepared and 10 everything sent in accordance with all our regulations. 11 So, I'd like to get his name and address after 12 the Meeting. 13 Yeah, I would think that SUPERVISOR CLAVIN: 14 would be a good idea to talk. 15 ATTORNEY O'BRIEN: Yup. SUPERVISOR CLAVIN: I know he just kind of came 16 17 in. 18 I think he just put in a slip. 19 If you could just stick around here. 20 ATTORNEY O'BRIEN: Sure. 21 SUPERVISOR CLAVIN: I saw the Mayor of Malverne. 22 You just came in there. 23 Mayor, did you want to speak regarding this project or if you go to the back, give you name and address 24 25 of the record, that'd be awesome.

1	Now come this way if you could in front.
2	Mayor, if just give your you name and address for
3	the record, that'd be great.
4	MALVERNE MAYOR SULLIVAN: Good Morning,
5	Supervisor.
6	Tim Sullivan, 119 Malverne Avenue, Malverne, New
7	York.
8	As you said, I'm the Mayor of Malverne.
9	And, I appreciate you having me here today.
10	Sorry, I was held up at another Meeting.
11	I had announced this Hearing at our Village Board
12	Meeting recently.
13	We're well aware that this property is located in
14	the Town of Hempstead, not within the Incorporated Village.
15	But we've had many residents express over the
16	years concern and really negative feelings towards the
17	condition of this property and how it's been maintained
18	over certainly over the last four years that I've been in
19	office and more recently as Mayor.
20	Trucks being stored there, garbage being
21	stored there.
22	I know I spoke with former Town Councilman
23	Bruce Blakeman when he was here, and the Town took some
24	action to maybe condemn the property.
25	I don't know what the action was, but

certainly had graffiti painted over. 1 2 They had fencing, site safety fencing put 3 around the property. 4 So the Town Board has been helpful to us as a Village and the residents, and for that we're appreciative. 5 6 But the condition of this property is just 7 awful. 8 As you know, we have a quaint small Village 9 that has a nice appearance, and the entrance to our Village 10 is this really rundown, broken windows, trash strewn 11 everywhere. Even if the intent of the landowner was to 12 13 redevelop this parcel, they should be doing it in a 14 tasteful manner where you have site fencing that maybe, you 15 know, masks what's being done behind, and that's not what they're doing here. 16 17 I didn't have a chance to review the amended 18 site plan. 19 I did see the Public Notice where there are 20 three gas or bays being installed, which I will note are 21 already in the ground. 22 So I'm not sure how that applies to this 23 application at this point. 24 I don't know if that's an amendment or an 25 add-on where there are two in the past.

1 So, I imagine that they want to increase 2 capacity. I also don't really know how the traffic 3 4 patterns are going to work. 5 But I would express on behalf of the 6 residents of Malverne Park and in the Town of Hempstead 7 concern if there was any traffic being redirected onto 8 Morris Avenue. 9 That's something that we would not want. 10 We wouldn't want cars exiting off onto 11 Morris and then through the Village. 12 We'd also - - and the Councilwoman Ryder had 13 told me that there were being hours proposed for the 14 convenience store. 15 We would advocate that they not be 24 hours, that the hours be limited and that any site plan considered 16 17 here today would take those into consideration. 18 And, of course, I've noticed that the 19 board has been advocating for tasteful landscaping. 20 That's something that we would certainly 21 ask for your consideration as well. 22 Thank you for having me. 23 SUPERVISOR CLAVIN: Thank you, Mayor. 24 I know you've been in communication with 25 us, and I appreciate you bringing up the facts. Be some

nice things to say about the village, too, just so you 1 2 know. Any other residents who did not sign in or 3 4 wish to be heard? 5 (Whereupon, no comments were heard. After, 6 the following ensued.) 7 SUPERVISOR CLAVIN: Mr. O'Brien, I'm just 8 going to be very forthcoming on this one with you. 9 I think you've heard from not only 10 neighboring officials, you've heard from my colleagues on 11 the Town Board as well as the residents. There's a real concern about this and the 12 13 visual and in addition, I do have concerns about the 14 traffic flow. 15 Even if you're pushing a right hand turn, then you're flowing the traffic directly into the Village 16 17 of Malverne. 18 I think there are a lot of key elements that 19 need to be worked on, coordinating. 20 Like I said, the Mayor is like two hundred 21 feet from the area and he might love the traffic flow down 22 there, he might not like the traffic flow. 23 But we all try and work together. 24 In addition, I think the residents, as well 25 as, myself and I don't want to speak for my Town Board, but

1	it's tough to really get a visual on this one.
2	It's tough to, you know, see exactly what
3	you're doing here and clearly not in black and white.
4	With that, is there anything you wanted to
5	add?
6	ATTORNEY O'BRIEN: Certainly, just one comment
7	I do want to make is that, generally, a location such as
8	this is usually a local gas station.
9	So it's usually the local residents that are
10	going to be coming to something like this.
11	But I have and understand what the Mayor said.
12	I understand what the Deputy Supervisor, what
13	yourself and the other board members have said and what the
14	community have said.
15	And, you know, I'd like to be able to address
16	those concerns in a concise, cohesive fashion and, you
17	know, send that back to the board, because I think at the
18	end of the day that this would be a great improvement to
19	that particular site and the area.
20	But you're right, the picture wasn't really
21	set forth in a manner that can be clearly understood.
22	So, I'd like the opportunity to be able to
23	take into account all the different comments that have been
24	made from everyone and be able to address those and
25	resubmit some of that sort of information, and hopefully

1 that will work to everyone's benefit. 2 SUPERVISOR CLAVIN: And I appreciate that. I do. 3 4 I do not want you to go into the premise 5 ever that the only people are going to shop at the gas 6 station are local. 7 I live within a drive of a gas station and I 8 don't go to the gas station, not because I don't like them, 9 it's because they charge about \$0.40 more a gallon. 10 Listen, I'm a frugal guy. That's the way it 11 is. 12 I actually drive to a neighboring community 13 because it's a lot cheaper. 14 So if the price is right, that's where the 15 resident is going to go. And maybe this gas station will have the 16 17 cheapest price on Long Island. 18 But if that's the case, then they're going 19 to get a lot of traffic. 20 And you have to be realistic with this one. 21 And like I said, this one's a little tough 22 to kind of get the visual around. 23 ATTORNEY O'BRIEN: Understood 24 SUPERVISOR CLAVIN: All right. 25 ATTORNEY O'BRIEN: We'll try to get that

visual. 1 2 SUPERVISOR CLAVIN: If I had a motion on 3 that. 4 COUNCILWOMAN RYDER: Mr. Supervisor, in 5 light of all the comments and concerns that have been made 6 for the lack of color renderings and an adequate traffic 7 study, which might I add, would be good to include, 8 perhaps, a no turn on Morris Avenue sign. 9 I suggest or make a motion that we adjourn 10 the application. 11 SUPERVISOR CLAVIN: Can I get a second on 12 the adjourn? 13 DEPUTY SUPERVISOR GOOSBY: Second. 14 CLERK MURRAY: Supervisor Clavin? 15 SUPERVISOR CLAVIN: Aye. CLERK MURRAY: Councilman Carini? 16 17 COUNCILMAN CARINI: Aye. 18 CLERK MURRAY: Councilman Dunne? 19 COUNCILMAN DUNNE: Aye. 20 CLERK MURRAY: Deputy Supervisor Goosby? 21 DEPUTY SUPERVISOR GOOSBY: Aye, but I'd like to add something, I've listened, and one of the things 22 23 that you did not do is send out cards to the residents that 24 are being affected by this, so they would have something to read or you have a meeting with them before you come back. 25

1	ATTORNEY O'BRIEN: Certainly, I could
2	resend. And anybody who's still here, I'm certainly
3	willing to meet with anybody in the back.
4	DEPUTY SUPERVISOR GOOSBY: Okay, thank you.
5	I vote Aye.
6	CLERK MURRAY: Councilman Muscarella?
7	COUNCILMAN MUSCARELLA: Aye.
8	CLERK MURRAY: Councilwoman Ryder?
9	COUNCILWOMAN RYDER: Aye.
10	SUPERVISOR CLAVIN: Mr. O'Brien, listen, we
11	appreciate this.
12	Obviously, look, you've got a lot of
13	concerns, and like I said, even from the Mayor next door.
14	I would ask any of the residents that came
15	here today to please give your name and number to Mr.
16	O'Brien.
17	There's been no decision here.
18	We've adjourned the hearing based on the
19	concerns of residents.
20	But you know what, like I said, we appreciate
21	it, but we're not where we need to be to kind of make a
22	decision on this one. All right.
23	ATTORNEY O'BRIEN: Understood.
24	And I feel also, while I don't live next door
25	to it, I live here, too, and I want to have something to be

1	proud of and meet those concerns.
2	SUPERVISOR CLAVIN: Absolutely and thank you.
3	And I thank all the residents for coming out
4	and talking.
5	And I do recommend, especially the gentleman
6	who said he didn't even know about the notice, riding by on
7	his bike, please give the information, and if and when this
8	hearing ever comes up again, we will keep the residents
9	informed.
10	And thank you, Mayor, for taking the time to
11	come out here today.
12	Madam Clerk, please go to the next item.
13	CLERK MURRAY: Yes, we have a combination of
14	companion Decisions.
15	Number 11 is the Application of BOLLA EM
16	REALTY, LLC. for a variance from provisions of the "GSS"
17	Ordinance to repeal and replace Restrictive Covenants, site
18	plan approval and install storage tanks - WANTAGH -
19	southwest corner of Wantagh Avenue and North Jerusalem
20	Road.
21	Accepting a Declaration of Restrictive
22	Covenants incidental to and in connection with granting the
23	petition of BOLLA EM REALTY, LLC for a variance from
24	provisions of the "GSS" Ordinance to repeal and replace
25	Restrictive Covenants, site plan approval and install

1	storage tanks - WANTAGH.
2	SUPERVISOR CLAVIN: All right. May I please have
3	a motion on Decisions 11 and 12, simultaneously?
4	Madam Clerk, is that correct?
5	CLERK MURRAY: Yes.
6	COUNCILMAN DUNNE: I move that the Board adopt
7	the items.
8	COUNCILMAN CARINI: Second.
9	CLERK MURRAY: Supervisor Clavin?
10	SUPERVISOR CLAVIN: Aye.
11	CLERK MURRAY: Councilman Carini?
12	COUNCILMAN CARINI: Aye.
13	CLERK MURRAY: Councilman Dunne?
14	COUNCILMAN DUNNE: Aye.
15	CLERK MURRAY: Deputy Supervisor Goosby?
16	DEPUTY SUPERVISOR GOOSBY: Aye.
17	CLERK MURRAY: Councilman Muscarella?
18	COUNCILMAN MUSCARELLA: Aye.
19	CLERK MURRAY: Councilwoman Ryder?
20	COUNCILWOMAN RYDER: Aye.
21	CLERK MURRAY: Both Decisions have passed.
22	SUPERVISOR CLAVIN: Thank you, Madam Clerk.
23	Madam Clerk, please call the Administrative
24	Calendar.
25	CLERK MURRAY: On the Administrative

1	Calendar, we have Items 13 through 47.
2	SUPERVISOR CLAVIN: Okay.
3	Any Member of the Board wish to speak on
4	the Administrative Calendar?
5	(Whereupon, no comments were heard. After,
6	the following ensued.)
7	SUPERVISOR CLAVIN: Okay, I have a couple
8	of people who want to speak.
9	I'll start with Felix Procacci.
10	Good Morning. If you would state your name
11	and address for the record, thanks.
12	FELIX PROCACCI: Felix Procacci, Franklin
13	Square.
14	On Number 39, what experience does John
15	Conroy have in working, operating and managing a water
16	system, Water department?
17	Mr. Procacci, it is an appointment from the
18	Town Board to the Water Authority.
19	It is very clear, you know Mr. Conroy's
20	extensive history as the Commissioner of probably one, if
21	not the largest Department of the Town of Hempstead.
22	We're dealing with sanitation pickup of
23	residents and that's a combination of sanitary,
24	environmental concerns, recycling concerns, also emergency
25	concerns.

1	He was here during one of the largest storms
2	in the history of Long Island, did a masterful job.
3	I think he has a resume that brings nothing
4	but expertise in management, overview and did a tremendous
5	job as the Commissioner of Sanitation during his tenure
6	here.
7	And, I think that speaks volumes.
8	And, that's why we think he's a proper fit.
9	FELIX PROCACCI: So, he doesn't have any
10	experience?
11	SUPERVISOR CLAVIN: No, I didn't say that at
12	all, Mr. Procacci. Don't put words in people's mouths.
13	I gave you exactly his
14	FELIX PROCACCI: You didn't mention water. I
15	just want to clarify what you said.
16	SUPERVISOR CLAVIN: No, no, no, I don't need
17	you to clarify anything. Mr. Procacci, please, in all due
18	respect, I don't need you to clarify any words that I say.
19	FELIX PROCACCI: Okay. Am I correct in saying
20	that you did not mention he has any experience in water?
21	SUPERVISOR CLAVIN: Mr. Procacci, I answered
22	the question.
23	FELIX PROCACCI: Okay. Yeah. Thank you.
24	There's a lot of issues. I don't live in that
25	area, as you know, but people are concerned about this, the

1	water rates going up.
2	What I'm always for is I think that you need a
3	board member that will bring transparency to it so people
4	can understand the system.
5	Why are the rates going up?
6	What are the current costs?
7	We need board members who call for meetings, if
8	meetings aren't being held, should reach out to the public
9	and say, why isn't this board, meeting?
10	There needs to be communication.
11	You emphasized that in the previous application
12	and I agree with you on that.
13	See, we agree on something, Don and see, it
14	could happen.
15	SUPERVISOR CLAVIN: Biggie hug coming soon?
16	FELIX PROCACCI: Yeah, it could happen.
17	But the thing is there has got to be
18	communication between the people and the Board, just like
19	there's communication here sometimes.
20	So, I just think that these Board Members should
21	encourage that if the Board doesn't meet on a regular
22	basis, he should reach out to community and tell and have
23	them come down here and complain and have those Board
24	Members removed if they don't want to meet.
25	But you need an active Board Member. I don't

1	know the money. I did try to look into this. I couldn't
2	find anything about the finances.
3	So I'm not going to render opinion whether it's
4	viable to take over or not, like anything like that.
5	But the communication has to be there. And I've
6	heard from all the residents who speak on this, it's
7	not.
8	And I can't find anything on the Town's website
9	either.
10	Thank you very much,
11	SUPERVISOR CLAVIN: Mr. Procacci, so, you know,
12	after this appointment, it is my understanding they will be
13	calling for a Meeting.
14	But, in all seriousness, John Conroy has done – –
15	He really did a tremendous job, a great Administrator in
16	Sanitation.
17	Like I said, it is a yeoman's job that not only
18	deals with simply picking up your garbage, it also deals
19	with recycling.
20	Tremendous amount of environmental concerns that
21	he had to deal with, with the State DEC and the Federal
22	government.
23	He also, as I said, helped administer during
24	any storm we've ever had here, Superstorm Sandy, through
25	any of the snowstorms, he's done a tremendous job.

1	And, frankly, during the time period I've been
2	here, he's probably not criticizing anybody else here,
3	he's a guy who generally gets nice compliments from people
4	all around because he does a solid job.
5	And, I have a lot of faith that he's going to
6	go on this and do a tremendous job.
7	No, I appreciate it. And if you'd like, after,
8	I'll give you a big hug because I enjoyed that moment.
9	Next, I'm going to call up Claudia Borecky.
10	Good morning. If you give your name and address
11	for the record.
12	CLAUDIA BORECKY: Claudia Borecky. 28 Washington
13	Drive, Co-Director of Allied Clean Air, Water and Soil.
14	The South Nassau Water Authority was fully
15	established with your three appointments and the two County
16	appointments in February of last year.
17	In Liberty's sales agreement with American Water,
18	L.I. Clean Air, Water and Soil made sure that the South
19	Nassau Water Authority was specifically named as a
20	municipality interested in acquiring Hempstead's portion of
21	American water.
22	Liberty agreed to a schedule for public
23	acquisition which, "shall" not, "may," shall commence
24	immediately upon the establishment of the Water Authority.
25	It provided six steps, beginning with giving the

1	Water Authorities 90 days after its formation to submit
2	document request.
3	Step 6 was to be taken place within 375 days and
4	provided that if and when the parties reach agreement for
5	acquisition by the Water Authority, the parties shall
6	draft, negotiate and execute a purchase agreement.
7	It is now over 450 days since the Water Authority
8	was fully established.
9	Dave Denenberg and I fought hard to set a
10	reasonable timetable for the public acquisition of Liberty.
11	Yet the South Nassau Water Authority, established
12	over a year ago, has not held one single Public Meeting.
13	The public takeover should have happened months
14	ago as prescribed in Liberty's sales agreement with
15	American Water.
16	Your Appointees have been derelict in their
17	duties.
18	It is egregious that you express outrage that
19	Liberty is raising our rates by 42% when it's your fault.
20	Blaming North and South Shore State Funding
21	Inequities as the reason not to meet is without merit.
22	Because the North Shore Water Authority has been
23	holding meetings without receiving a dime from the State
24	for over a century.
25	The Town and County have had no problem

1	collecting more than \$15 million per year in taxes that are
2	paid by Liberty's Hempstead customers, which no other
3	ratepayer on Long Island pays.
4	The true inequity is the Town and County taxing
5	private rate water ratepayers, while providing tax
6	free municipal water to over 80% of its residents.
7	Since those taxes are only paid by Liberty's
8	customers, some of that money should be set aside for the
9	Authority's operations.
10	Your Appointees must do their jobs.
11	The public needs to hear the status of its
12	negotiations with Liberty. It needs to Meet now.
13	I just like to say that as far as the actual
14	Commissioners go and a way of contacting you, there is
15	nothing on the website that gives us a way to contact the
16	Water Authority or the Commissioners.
17	And some of the emails I had were wrong.
18	(Whereupon, the three-minute bell rang. After,
19	the following ensued.)
20	CLAUDIA BORECKY: So I appreciate your correct -
21	-
22	SUPERVISOR CLAVIN: I appreciate and as I said,
23	it's my understanding that after the appointment's done,
24	they'll be calling for a Meeting.
25	And, thank you, again for raising the concern

1	that the Governor felt fit to give the North Shore Water
2	Authority, with substantially less customers, a million
3	dollars, while not giving to the South Shore customers any
4	money whatsoever.
5	It's unfortunate.
6	And lastly, Ms. Borecky, thank you so much. You
7	had your chance.
8	The last thing I do want to point out and I do
9	appreciate it, was my understanding that there were some
10	recommendations that David Denenberg be appointed to the
11	Water Authority but I think at the last Meeting, Councilman
12	Carini pointed out that it would have been illegal to us to
13	appoint him.
14	What was the reason why?
15	CLAUDIA BORECKY: Can I
16	SUPERVISOR CLAVIN: No, Ms. Borecky, Ms.
17	Borecky, you've had your chance.
18	Thank you, Ms. Borecky. Mrs. Borecky, Mrs.
19	Borecky, you had your three minutes.
20	Thank you so much. Councilman Carini No,
21	that's okay, you can yell all you want, Mrs. Borecky.
22	Councilman Carini, Councilman Carini, Councilman Carini
23	is going to gentlemen, if you turn off if Mrs. Borecky
24	likes to scream.
25	Anyway, Councilman Carini, could you explain to

1	Mrs. Borecky why it would have been illegal?
2	Why Mrs. Borecky, you can stand in the back.
3	Public Safety is going to ask you to please, Ms.
4	Borecky, you're making me nervous.
5	You're making me very nervous. You're making me
6	very uncomfortable.
7	Mrs. Borecky, Mrs. Borecky, please. Thank you so
8	much.
9	(Whereupon, yelling from the audience by Mrs.
10	Borecky continues. After, the following ensued.)
11	COUNCILMAN CARINI: Can I speak?
12	SUPERVISOR CLAVIN: Councilman Carini, if you can
13	explain to
14	(Whereupon, Mrs. Borecky walking around and
15	yelling. After, the following ensued.)
16	SUPERVISOR CLAVIN: That's very nice.
17	I'm very uncomfortable. Thank you.
18	COUNCILMAN CARINI: So the issue I have with Cause
19	is their Code Director.
20	They were circling a petition to put an eight-time
21	convicted Felon who pled guilty for eight felonies for
22	milking, as per Newsday, \$2.3 million from his clients.
23	Now, when I hear Cause and their, "their
24	statistics," their Co-Director, by the way, who you were,
25	his Legislative Aide, basically, I have a problem with

their integrity, their numbers, because he was pled guilty 1 2 and served a 90-day sentence for 2.3 million for taking that from a client. 3 4 So, I am really sorry if I do not trust his 5 numbers. 6 I don't trust his integrity. 7 And no, I will not take anything. Have a good 8 day, Ms. Borecky. 9 SUPERVISOR CLAVIN: Ms. Borecky, Ms. Borecky, 10 thank you. 11 Rich Moskowitz is next. Rich Moskowitz, here's 12 your opportunity to be heard. 13 Ms. Borecky, please. Public Safety, I'm feeling very uncomfortable with Ms. Borecky approaching us and 14 15 screaming in this fashion. Commissioner, if need be, please. 16 17 I'm feeling very uncomfortable again. 18 COUNCILMAN CARINI: Have a good day, Ms. Borecky. 19 It is a very uncomfortable, SUPERVISOR CLAVIN: 20 hostile situation being created by Ms. Borecky. I'm sorry, 21 I am very sensitive. 22 Mr. Moskowitz, this is your opportunity instead 23 of Ms. Borecky screaming. 24 Sir, thank you so much. 25 My name is Rich Moskowitz. RICH MOSKOWITZ:

I live at 3083 Whaleneck Drive, Merrick, New 1 2 York. The reason why I'm here is that I'm just a 3 homeowner in Merrick since 1974. 4 5 And I went through about four or five different 6 Water Companies already. 7 And through the time, I understand Mr. Denenberg you know, was locked up once, whatever. 8 9 I was in law enforcement, whatever, that some 10 people can be reformed. 11 So, I could understand integrity and that 12 matter of fact, what was done between Borecky, Denenberg. 13 But I'm not concerned about that. What I'm concerned about is that when you read 14 15 some of the statistics how we pay nine hundred dollars to have a hydrant where other public water places only pay 16 17 seventy dollars, it's all reflected and it involves an 18 awful lot of homeowners. 19 And, when I speak to my neighbors, whatever, 20 some that are politically, astute they say, "how come nothing is ever being done about it?" 21 22 And, naturally you just throw up your hands. 23 But Denenberg and Borecky are the only ones, no matter what their background is, that have done 24 25 anything.

1	And one thing
2	COUNCILMAN CARINI: Well, their background
3	does matter, sir, because I was in law enforcement too.
4	And if you're aware, Mr. Denenberg also pled
5	guilty to a misdemeanor years prior for signatures.
6	So, this is not the first time he's pled
7	guilty.
8	So, as a former law enforcement officer, I am
9	sorry, his integrity matters to this Board.
10	And Mr. Town Attorney will explain the process
11	of how this New York Water Authority Board will operate.
12	Now, the problem I have is they provided no
13	funding.
14	No funding like North Shore. None.
15	I also pay American Water.
16	I pay triple the amount of money. It's a
17	crime.
18	But the bottom line is the State broke it.
19	They didn't want to fix it and they threw it
20	out to the ocean.
21	And I'm sorry if I don't I may speak, Ms.
22	Borecky, you spoke.
23	So, this Long Island Cause is, basically, a
24	former Legislator and his Aide to resurrect a dead
25	political career for her former boss who has, again, pled

1 guilty. 2 Didn't fight the charge. He went "guilty," "guilty," "guilty" for eight 3 felonies counts, that's as per Newsday. This is not me. 4 5 This is as per Newsday. He then served a 90-day sentence at a Federal 6 7 jail, again, as per Newsday. 8 So yes, I do have a problem with this 9 organization's integrity. 10 The two people that run it have a very 11 checkered past. 12 And, I'm not going to listen to a former 13 Legislative Aide of a convicted felon try to resurrect a 14 political career here at the Town of Hempstead. 15 The Town Attorney will explain how the Water Authorities can go forward, what we're required to do. 16 17 We can do that, Mr. Town Attorney, and that's 18 what he is going to say. 19 So, I'm sorry, I do not take any credit to what 20 Ms. Borecky and Ms. Denenberg said. Period. Have a good day. Thank you. 21 22 SUPERVISOR CLAVIN: We're going to go through 23 the sign-ins just like Ms. Borecky had a chance to yell, 24 Mr. Moskowitz. 25 I'm going to go through a couple others.

1	No, no, ma'am, have a seat.
2	Patricia Hyland. Oh, it's Ms. Hyland's turn,
3	Ma'am, Ms. Hyland's turn.
4	No, we go through the sign-in sheet and then I
5	give you opportunity to speak, ma'am.
6	Ms. Hyland, if you give your name and address
7	for the record. Thank you.
8	PATRICIA HYLAND: My name is Patricia Hyland.
9	I live at 2309 Howe Street in Merrick. I have
10	been living there for 20 years.
11	And, 22 years before that, I lived in Baldwin.
12	So, it has been Town of Hempstead all the way.
13	And, it has always troubled me that our cost of
14	water is so much greater than Freeport, for example, and
15	other communities.
16	My understanding recently is that Liberty
17	Utilities is requesting an outrageous, like, 42% increase
18	in the cost of water.
19	I understand that there was a Bill passed to
20	set up the South Nassau Water Authority and that no Public
21	Meetings have taken place.
22	I also understand that North Shore and
23	Massapequa have also been invited to set up public water
24	utility of water.
25	And, though money was, um, put offered by

1	the State, that money was never delivered to them.
2	So it did not impede them from having meetings
3	and making progress toward starting the public control of
4	water in our area.
5	So, I'm not finding the fact that the money is
6	not present a good excuse for there not being Public
7	Hearings.
8	So, I am requesting that Public Hearings begin
9	immediately since the last person to the Board is being
10	appointed.
11	That's what this meeting is about.
12	I have no idea of I'm not familiar with
13	that person, but I'm delighted that the last person has
14	been assigned.
15	And I want people on the Board here and in the
16	audience to understand that delay on having Public Hearings
17	cost the taxpayers money.
18	I made a nice little poster because sometimes a
19	visual is helpful.
20	The fact that this is delayed is costing us
21	taxpayers money and I expect better service than that.
22	So, I'm hoping that this will move forward
23	very quickly. Thank you.
24	SUPERVISOR CLAVIN: Thank you, Ms. Hyland. We
25	appreciate your nice comments.

8	time for public water.
9	Other places have done it.
10	It's possible, and I would hope that we would
11	hear some progress report in some way soon.
12	I was disappointed, really, in the
13	discussion earlier.
14	It sounded like sort of a character
15	assassination.

17	going on with the person's background, but I

20	hope Mr. Conroy is good for this job.

10	LEONARD SUSMAN: Good morning. Leonard
11	Susman.
12	I live at 1767 Park Avenue in Merrick, North
13	Merrick.
14	I've been a resident since 1969.
15	And, I believe the Town needs to expedite the
16	move toward public water.
17	It seems somewhat unconscionable that the
18	citizens who are within the Liberty Service Area
19	are paying the rates they are paying and that
20	while the Public Service Commission and the rules
21	may allow the level of increase that is sought,
22	it is a burden on the residents, which I would
23	hope the Town, in its wisdom and its desire to
24	serve its constituents, would make a more
25	determined effort to correct the inequity of the

1	citizens having to pay the rates that they are
2	currently paying and are projected to pay in the
3	reasonably near future, should the rates be
4	formally approved.
5	I'm not sure if they have been as yet, but
6	it does seem like it is more than a reasonable
7	amount of increase, given inflation.
8	As to the question of the individuals that
9	have been mentioned today as possible for
10	consideration for appointment, in all fairness to
11	Mr. Denenberg and to the Councilman, our society
12	does allow for people to, over the course of
13	time, shall we say, compensate for misdeeds that
14	they may have done.
15	As I recall, the situation with Mr.
16	Denenberg, it admittedly was wrong.
17	And I believe he has come to grips with that
18	over time.
19	I think some of the other good deeds that he
20	has done with regard to the environment, with
21	regard to the beach, shore cleaning and other
22	services through the Kiwanis America-wanis, in
23	terms of being responsible for food drives and I
24	don't know what other deeds he has done within
25	the Kiwanis environment.

(Whereupon, the three-minute bell rang.
After, the following ensued.)
SUPERVISOR CLAVIN: Mr. Susman, we appreciate
your very thoughtful remarks.
LEONARD SUSMAN: Pardon?
SUPERVISOR CLAVIN: We appreciate your very
thoughtful remarks on both the water and the
individual.
As I said, I believe that after today's
appointment is done, the Water Authority will be
doing a Hearing.
And when they do, we'll put it on the
Town's website.
If you'd like to give your name and number
to one of the Aides, here, today, I'll be happy
to make sure they send an email out to you to let
you know when.
But we appreciate your very thoughtful
comments here today.
Next, I have Francine McDaniel? Francine
McDaniel? No?
Okay, I have Barbara Hafner.
How are you doing?
Good morning. Can I have your name and
address for the record?

1	BARBARA HAFNER: Yeah Hi. Barbara Hafner.
2	202 Walker Place, West Hempstead, New York.
3	I, too, am a Liberty Water customer
4	unfortunately.
5	On my block, we live in the house that my
6	husband's parents built in 1950.
7	Just like the previous gentleman, I've had
8	several private companies take my money.
9	And on my block, you have three houses that
10	have West Hempstead Water.
11	My house and everyone on my side has Liberty
12	Water.
13	I've been a Union Leader.
14	I was the President of my Union for 19 years.
15	I served on the Long Island Federation of
16	Labor Board for ten years, and I've served on the
17	Nicer Board of Directors for 14 years.
18	I know what union leadership, and in
19	particular, I know what your leadership is all
20	about.
21	And leadership is representing their members.
22	And I see you as elected officials, as your
23	responsibility is to represent your members.
24	And we are your members, the people who live
25	in the Town of Hempstead.

1	I don't know why this has taken so long.
2	I have no problem reaching out to the State
3	government officials that I have elected to
4	represent me to find out if you need this money
5	immediately, let's get it done, because this is
6	taking much too long.
7	My bill I got yesterday was \$175 for one
8	month.
9	My neighbor across the street three month
10	bill was \$60.
11	You tell me what's wrong with that picture.
12	And today in Newsday, Liberty Water is now
13	suing Lawrence because they're not paying their
14	water bill for their fire hydrants.
15	God forbid there is a fire and there's a problem
16	with their water. Come on.
17	This is an election year. I will be sure to
18	make sure that every person that's going to
19	represent me is on top of this.
20	And I expect you, Mr. Muscarella, you are
21	my representative, you all got letters from me
22	asking what's happening.
23	I even volunteered to sit on the Commission
24	because we need to get moving here.
25	No more dragging feet, no more excuses.

1	This is not about any organization. This is
2	about the people that you represent.
3	And it's time to truly represent us and
4	care about the money that I am spending for water
5	that should be public. Thank you.
6	SUPERVISOR CLAVIN: Thank you. Ms.
7	Hafner. Dorothy Kozel. Good afternoon, Ms.
8	Kozel.
9	If you give your name and address of the record.
10	DOROTHY KOZEL: Dorothy Kozel. 221 Walker
11	Place, West Hempstead.
12	I just have one question and actually an
13	observation.
14	We spent a half hour talking about a
15	garage, and everybody on the Board seemed very
16	concerned.
17	We're spending, now, ten, fifteen minutes
18	on this water issue that involves thousands of
19	people, and none of you look like you have the
20	same concern over this water issue as you have
21	about a garage.
22	My question to you is, why is it that it's
23	taken our South Nassau Board to be formed one
24	year, and yet the North Nassau and the Massapequa
25	Boards are more than halfway on their way to

1	getting their water public.
2	SUPERVISOR CLAVIN: Well, like I said,
3	we're doing the appointment today.
4	DOROTHY KOZEL: Why did it take a year for
5	us?
6	SUPERVISOR CLAVIN: And we had a couple of
7	members that, you know what, they ended up having
8	to resign from the Board.
9	One of them was blessed to be as a Town
10	Board Member.
11	Like I said, it's the appointment.
12	They'll be doing their meetings.
13	And as of for the other jurisdictions, I'm
14	not too sure what they're going to do.
15	Maybe you have insight that I've heard
16	numerous things about.
17	I'm just saying you've made a
18	representation but I'm saying I've heard numerous
19	things that those entities may or may not be,
20	now, making the recommendation.
21	I think it's something we all need to
22	monitor.
23	Hey, listen, everyone said LIPA was going
24	to be the greatest thing in the world.
25	You know what, it didn't quite work out as

1	well as some people thought.
2	So I said, well
3	DOROTHY KOZEL: It is not our concern.
4	SUPERVISOR CLAVIN: Actually, it is our
5	concern, because you just said if the other
6	entities find out that it's actually going to
7	cost communities more for it, this is a good
8	process.
9	That's why you just can't say it's going to
10	be done.
11	The Board will meet, we'll course, let the
12	residents know by putting it on the Town's
13	website when they're going to go meet, and you
14	can go down, you express it to them.
15	And, like I said, John Conroy is going to be
16	a great asset to this Board.
17	He's done a tremendous job, and they'll do
18	their due diligence.
19	They'll do it in an open and transparent
20	manner, and they'll do a great job.
21	DOROTHY KOZEL: When will they have their
22	first Meeting?
23	SUPERVISOR CLAVIN: Again, I said earlier,
24	when we find out when they're going to have their
25	first Meeting after the appointment, because they

1	couldn't do the again, they can't do the
2	appointment until they can't schedule the
3	Meeting until after the appointment.
4	We'll be happy to let you know.
5	DOROTHY KOZEL: Thank you.
6	SUPERVISOR CLAVIN: Okay. Thank you.
7	Eleanor Wexler?
8	Good Afternoon. If you give your name
9	and address for the record.
10	ELEANOR WEXLER: My name is Eleanor
11	Wexler. I live at 2707 Lincoln Boulevard in
12	Merrick, for over 48 years,
13	I've seen other water companies, Brooklyn
14	Water, American Water, now, we have Liberty
15	Water.
16	Neighboring districts have public water.
17	Why do we have a Canadian company, Liberty
18	Water, representing us?
19	Why don't we have public water, too?
20	We're looking at a 42% increase in our
21	bills in the future.
22	Mr. Clavin, please support us.
23	We need your help in getting public water
24	like our neighbors.
25	Thank you.

1	SUPERVISOR CLAVIN: Thank you, Ms. Wexler.
2	Thank you very much. We appreciate you coming today.
3	I have James Jacobs. Did you want to speak on this as
4	well, Mr. Jacobs?
5	JAMES JACOBS: No, on the Administrative
6	Calendar.
7	SUSPERVISOR CLAVIN: On the Administrative
8	Calendar?
9	JAMES JACOBS: Yes.
10	SUPERVISOR CLAVIN: Good Afternoon. Give
11	your name and address for the record? That'd be
12	great.
13	Item number, what, on the Administrative
14	Calendar?
15	JAMES JACOBS: Number Item 20, about
16	the taxation.
17	SUPERVISOR CLAVIN: Which one?
18	JAMES JACOBS: Okay. The first number in
19	front of it forgive me.
20	SUPERVISOR CLAVIN: No worries.
21	JAMES JACOBS: No, I want to do it
22	correctly.
23	Good morning or Good afternoon,
24	Supervisor, Deputy Supervisor Goosby and Council
25	people.

1	The first number is 2964, Item is 23.
2	And basically I want to have a clarification
3	of taxation programming from Harris governing about
4	what's the new tax function for collection of
5	financial management information, point of
6	clarification.
7	SUPERVISOR CLAVIN: So you're asking about
8	Number 23 for the Harris Govern for the computer?
9	JAMES JACOBS: Yeah, because it's going to
10	be some kind of change being made and being
11	SUPERVISOR CLAVIN: If I'm not mistaken and
12	you correct me if I am wrong, it's a system update
13	they're doing for the tax system.
14	They use that system and every periodically
15	they do upgrades in the system and you got to buy into
16	the upgrade, that's how they kind of lock you in.
17	JAMES JACOBS: I understand it that
18	Supervisor, but my question for clarification that
19	when you do upgrade, it's pertaining for new tax roles
20	for the property, corporate, whatever.
21	When you do upgrades it uses the function
22	of another program pertaining to the function in a
23	computer for tax purposes.
24	SUPERVISOR CLAVIN: You have the existing
25	software and then they do periodic updates.

1	You know, of course, as you're well aware,
2	the tax office doesn't do any determinations on
3	assessments or anything like that, that's done by the
4	County.
5	In addition, the software upgrade could be
6	the fact that when the County updates their system,
7	the municipalities also have to update their system so
8	they can all communicate because the county transfers
9	the data down to the different jurisdictions like the
10	Towns and the Cities.
11	So, this is just merely an IT-related
12	update on the software.
13	JAMES JACOBS: Okay, I understand that.
14	That's why when I make my check out to the Town's Tax
15	Receiver that's pertained to the new information from
16	this computer system being installed in it.
17	SUPERVISOR CLAVIN: You've lost me.
18	JAMES JACOBS: Well, that's what I'm trying
19	to understand what you're saying because when I make
20	my check out
21	SUPERVISOR CLAVIN: The County values your
22	property.
23	The County then sets your assessment.
24	The County then gets the numbers from the
25	School Districts will say and calculate based on, you

know, the different classes what everyone has to pay 1 2 in property taxes. This update software is just merely so they 3 can get the information, print out the bills, mail it 4 to you, you can send it to Ms. Driscoll and then 5 6 she'll forward them to the School Districts of the 7 County, whatever entity is getting the money. \setminus JAMES JACOBS: Okay, since you explained it 8 9 that way, it's a better understanding. 10 Okay, I just want to make sure we're on the 11 same page when I come to the Town and pay my taxes. 12 I'm going to make sure it goes to the right 13 people for the right rate and thank you for that. SUPERVISOR CLAVIN: That's it? 14 15 JAMES JACOBS: Yeah, that's it. SUPERVISOR CLAVIN: All right. 23	the laws, even though you have a law on the books, but
24	laws without teeth are absolutely useless regarding
25	this.

I'm going to speak to Councilman Dunne. 1 2 I know you are a Veteran and thank you for 3 your service, sir. We have Veterans that live in our communities 4 5 that they have PTSD. I know a few of them that have PTSD. 6 7 This takes a toll on their mental health. So 8 much so that one of our Veterans, elderly man who served in one of our previous wars, he cannot stay in 9 10 his home during the Summer. 11 I'll wait till you stop speaking, Mr. 12 Supervisor. 13 SUPERVISOR CLAVIN: No, Ms. Jacobs, it's your 14 time. 15 One thing I know about the Councilman, he's listening to you. 16 17 And I said to him, everyone can hear you. 18 PEARL JACOBS: Councilman Dunne, I'm imploring 19 to you to help the Veterans who suffer from this PTSD, 20 who have to - - this gentleman has to leave his home 21 from April to September because he cannot deal with the barrage of fireworks that occurs in his 22 23 neighborhoods. 24 Now, these people fought for our Country, died 25 for our Country and they can't come and they can't

1	enjoy their neighborhoods.
2	And with the taxes that they pay here, whether
3	they pay no taxes at all, you should be able to have a
4	good quality of life.
5	They've had enough explosives and detrimental
6	effects to their mental health. They don't need any
7	further. I would ask our Veteran
8	SUPERVISOR CLAVIN: It doesn't work that way.
9	PEARL JACOBS: Can you stop talking over me?
10	I'm talking to Councilman Dunne.
11	Councilman Dunne, I would hope that you help
12	us with this. Thank you so much.
13	SUPERVISOR CLAVIN: Ms. Jacobs, perhaps you
14	can actually give the name and address of the Veteran,
15	but also remember that the County Police Department,
16	which do a tremendous job, would be in respect to the
17	enforcement.
18	And I know that they work very, very closely
19	with a lot of organizations, a lot of civic groups in
20	Uniondale.
21	And if there are constantly fireworks going
22	on in this guy's house from April to June, of course -
23	_
24	PEARL JACOBS: Well, not in his house all
25	over the community, all over the community, okay.
