25	intersection of Freeport Avenue.

1	Stop signs at this location is the biggest
2	request we get from our community.
3	And, if we had not received any opposition
4	to the placement of these Stop signs, these Stop signs
5	would be placed at the main pedestrian crosswalk in town
6	and would stop drivers and provide a measure of safety to
7	pedestrians at the busiest crosswalk in Point Lookout.
8	There are already existing crosswalks at
9	this location, but nothing to stop traffic.
10	There are no Stop signs for the entire
11	length of Lido Boulevard, while in Point Lookout, that is
12	at twelve blocks without any sort of Stop sign to control
13	traffic.
14	These Stop signs would force drivers to slow
15	drivers down and stop halfway through town.
16	Finally, there are four East/West roads in
17	Point Lookout.
18	The only one of those that does not have a
19	Stop sign at Freeport Avenue is Lido Boulevard, which is
20	the main intersection, which is the main road in town.
21	As such, we are asking that you please
22	approve this measure.
23	Thank you for your time and consideration.
